### Department of Housing and Economic Development Palm Beach County Five Year Consolidated Plan 2025-2029 Community Needs Public Meetings

Palm Beach County must prepare a Five Year Consolidated Plan in order to receive federal grant funding from the U.S. Department of Housing and Urban Development. The Plan will identify community needs in the areas of housing, economic and community development. It will also establish priorities for the use of Community Development Block Grant, HOME Investment Partnership, and Emergency Solutions Grant Program funding during the October 1, 2025 to September 30, 2029 time period.
