#### I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to adopt: Resolution of the Board of County Commissioners of Palm Beach County, Florida, amending the County Administrative Code to change the name of the Department of Economic Sustainability to the Department of Housing and Economic Sustainability, and providing an effective date.

Summary: Amendments to the County Administrative Code require a resolution approved by a majority of the members of the Board. The attached resolution amends the County Administrative Code to rename the Department of Economic Sustainability, the Department of Housing and Economic Sustainability. The renaming of this department will place more emphasis on housing as a priority of the Board of County Commissioners and more accurately describe the responsibilities of the department. Countywide (PK)

Background and Justification: The mission of the Department of Economic Sustainability is "To advance community sustainability by increasing economic competitiveness and improving the elements that create a high quality of life for Palm Beach County's residents". The mission will be revised following the name change to reflect affordable housing programs and activities as a principal responsibility of the department and a key component of quality of life for county residents.


