# ADDRESSING FORECLOSED AND ABANDONED HOMES: THE GRAMERCY PARK HOME REHABILITATION PROJECT



Ron Mulberry, Senior vice President of Federal Property Registry Corporation (FPRC), will be in attendance to talk about what his organization does in partnership with Neighborhood Champions (NC), provide information on the abandoned home remodeling project in Gramercy Park and discuss other possible sites. Mr. Mulberry is the Liaison between FPRC and non-profit organizations such as Neighborhood Champions (NC), which in turn partners with various organizations to renovate foreclosed and abandoned homes which are eventually rented, sold or donated to low income residents.

In response to the foreclosure crisis, FPRC funds the projects and work together with partnering organizations and local government to help communities all over the nation fight blight through aggressive strategies. These strategies include education, collaboration, and utilization of programs that induce blight resolution, home value stabilization, and new home-ownership opportunities.
