Jose Cintron has had a distinguished career in the field of housing and community development for over thirty-seven years. During that time he has served in various senior executive level jobs in federal, state, county and city governments. His various roles have afforded him the opportunity to influence strategic public policy formulation at all levels, and also to be responsible for implementing said policies and producing impactful results for the constituencies he has helped to foster. He is currently serving as the Miami Field Office Director, named to that post in March of 2015; a position he first held almost twenty years ago. In January of 2010, he rejoined US Department of Housing and Urban Development (HUD) to become the Director of the Miami Hub for Public and Indian Housing.

His other HUD service encompassed two years as the Regional Public Housing Director, twelve years during which time he held positions as the Secretary's Representative (Regional Director) for New York and New Jersey (appointed by Secretary Henry Cisneros), Field Office Director for the Florida State Office, Acting General Deputy Assistant Secretary for the Office of Public and Indian Housing, Acting Director of Community Planning and Development of the Miami Field Office, and Development Coordinator for the Public and Indian Office of Miami. During this period he also served as the "Change Agent" (appointed by Secretary Andrew Cuomo) responsible for the reorganization of the HUD Public Housing Division.

Prior to originally joining HUD, Mr. Cintron spent almost two decades working in the City of New York. Here as well, he responded to many different challenges with commitment, creativity and excellence. His NYC highlights included Chairing the Board of Estimate (the governing board of the city) as the Representative of Mayor Edward I. Koch; serving as the Vice-President of the New York School Construction Authority, holding the position of Assistant Commissioner for Community Development and Neighborhood Preservation for the NYC Housing and Preservation Department, and as Director of several other divisions in various NYC Departments including the Housing Development Corporation, the Community Development Agency, the Manhattan Borough President's Office, and the local Community Planning Board for the District known as East Harlem. In addition, early in his career he led the East Harlem Office for the Honorable Congressman Charles B. Rangel. Mr. Cintron also served with distinction in senior executive leadership positions in Miami Dade County beginning in 2007 before returning to work at HUD in 2010.
