Join the Countywide Community Revitalization Team (CCRT) for a public meeting hosted by the Office of Community Revitalization (OCR) on Tuesday, January 21st, at 10 a.m. The meeting will be held at the Vista Center, located at 2300 N. Jog Road in West Palm Beach.

Charles A. Vercillo, Esq., from Florida Rural Legal Services, Inc. (FRLS), will be in attendance to talk about FRLS' Community Needs Assessment Survey. FRLS was founded in 1966 and provides legal services within thirteen (13) Florida counties to low-income individuals and families, migrant and seasonal farmworkers, senior citizens, and people with disabilities. FRLS provides free legal services regarding housing, family law, public benefits, individual rights, consumer rights, elder law, immigration, education, medical services, farm worker law, labor and employment, domestic violence, victims of crime, and violence against women. FRLS is seeking community-wide input via survey to identify the legal issues that many low-income citizens face with the goals of educating citizens and resolving these legal issues.

In addition, OCR staff will provide a brief overview of the CCRT Areas Reassessment Study currently underway. The study is intended to:

1. Evaluate all existing CCRT areas to ensure they are in need of assistance;
2. Identify other potential areas in need of assistance within unincorporated Palm Beach County; and
3. Prioritize which areas should be the focus of a concentrated revitalization effort.

Please join us and provide input on the presentations and what is needed and/or desired to make your community a safer and better place in which to live. This meeting will also give you the opportunity to discuss your community needs with the appropriate county agencies as well as other community leaders.
