Join the Countywide Community Revitalization Team (CCRT) for a virtual WebEx meeting hosted by the Office of Community Revitalization (OCR) on Tuesday, May 10, at 10 a.m.

**James Green, Director of the Palm Beach County Community Services (CS) Department**, will be in attendance to talk about services offered by CS. Mr. Green's presentation will focus on the Emergency Rental Assistance (ERA) program approved by the Board of County Commissioners last year. The ERA program provides rental assistance to Palm Beach County residents who experience a loss of income as a direct result of COVID-19. In addition, Mr. Green will go over the Utility Assistance program (LIHEAP), designed to provide financial relief from high-energy costs to prevent service disconnection for families in crisis, and the Homeless Services Program that assists homeless individuals through outreach, assessment, and housing.

**Valerie Aubourg, Associate Practice Administrator with Foundcare, Inc.**, will also be in attendance to provide information about her organization. Ms. Aubourg's presentation will focus on the unmet health care and social service needs provided by Foundcare to Palm Beach County residents. Upcoming Foundcare projects will also be discussed.

The OCR has also invited Steve West, Founder of The In-Crowd to attend this meeting to give an update on the OCR's CCRT Communities/The In-Crowd Partnership Initiatives.

An update on initiatives undertaken by the OCR to assist the communities it serves will also be provided during this meeting.

This public meeting will also be an opportunity to network with county agencies, OCR partners, and other community leaders who, like yourself, are making a difference in their community.
