II. DEPARTMENT UPDATES

- Anna Stewart, Drowning Prevention Coalition of PBC
 - The coalition provides a free educational program. A minimum of ten people is needed to have a class. The coalition will come to community, HOA, or business meetings to give a presentation. The coalition is having a big marketing push on how to escape a sinking vehicle that goes into a body of water. It is one of the leading causes of drowning in PBC.

 - Established in 1951 under the Migratory Bird Conservation Act
 - Northernmost part of the remaining historic Everglades.
 - o Over 145,188 acres of Everglades's ecosystems.

Mission:

 "Working with others to conserve, protect, and enhance fish, wildlife, and plants and their habitats for the continuing benefit of the American people."

What is a National Wildlife Refuge

- Refuges are for wildlife, parks are for people
- o Originally established to conserve waterfowl.
- Over 570 National Wildlife Refuges in the U.S. with over 850 million acres of land.

· Wildlife on the Refuge

- o Over 250 bird species
- o 60 reptiles & amphibians
- o 40 species of butterflies
- o 20 types of mammals

 - Her daughter attended the Youth Everglades Conservation Camp. This camp is from Sunday to Friday. This is an excellent and inexpensive sleep-away camp. This camp also provides community service hours for students who are chosen to be camp counselors.

 - His fraternity has a partnership with the Wildlife Service. The fraternity's youth group attends the facilities.

 - Inquired about the culinary/community garden program and would like to have more information

V. RESIDENT QUESTIONS/COMMENTS

- William Muth, Palm Acres Estates-Congress Meadows Resident
 - Following a noise complaint a neighbor has bright lights shining on his car and in his house where he sits. The neighbor advised he would take care of the problem but never did. Mr. Muth advised that he does not have the money to get a lawyer.
 - o Mr. Muth advises that there is constant loud music from his neighbors mainly on the weekends until late hours in the night.
 - Mr. Muth stated that one of his neighbors has a camper parked in the rear of the home with several individuals living in the camper.
 - When one of the neighbor's septic tank fills up the neighbor is releasing the raw sewage into his hedges instead of getting the septic tank pumped.
 - Richard Padgett with Code Compliance advised that he would meet with Mr. Muth following the meeting to get more specifics and the exact addresses of the complaints. He will then have the issues followed up on.
- Katharine King, CAM Estates resident gave an update on the following concerns.
 - Katharine King, CAM Estates Resident gave an update that the box truck parked at 1021 Cameo Circle is no longer there.
 - Fadi Nassar advised that PBC Road and Bridge has added the mowing of the right of way to the lawn maintenance schedule
 - Houston Tate advised the preliminary plans have been done for the extension of the sidewalk for students and pedestrians.
 - Ms. King advised there are traffic issues in the community because the students of the elementary school are being bussed to another location while their school is being modernized.
 - Houston Tate advised there needs to be a meeting about the installation of speed humps in the community.
 - Ms. King gave an update on 1148 Cameo Circle. The homeowner has removed the debris that was in the front yard.
 - Ms. King advised that the box truck at1021 Cameo Circle has been moved
- James Getty, Melaleuca Avenue-Pine Air West Resident presented the following concern.

- Mentioned the ongoing traffic concerns around Berkshire Elementary on Kirk Rd. He advises the enforcement actions taken to clear the rights-of-way on Collin Dr., have caused parents to begin parking over the sidewalks down Chukker Drive. Richard Padgett, PBC Code Compliance forwarded the concern to Captain Mugridge with PBSO. Captain Mugridge advised that he will have enforcement to monitor the areas.
- Michael Owens, School District of PBC, stated that he spoke with Mr. Getty after the CCRT meeting to discuss the issues he has engaged School District staff and is looking to set up a meeting at Berkshire Elementary in a week or so.
- Larry Diegert, Plantation Resident
 - Would like turning lanes at the intersection of Belvedere Rd & Drexel because of the difficulty in turning without the turning lanes. Fadi Nassar advised that certain criteria must be met before turning lanes can be installed. Traffic Engineering will evaluate this area. Evaluations are done once a year.
- On September 19th Code Compliance received a complaint from Judy Smith, CAM Estates resident. She states the construction at Wynnebrook Elementary awakened her shortly after 4:00 am. Richard Padgett explained the county ordinance for construction hours, is 7:00 AM 10:00 PM, Monday Saturday. He also explained the school district is a self-governing entity, exempt from local building ordinances. Michael Owens forwarded the complaint to the modernization project team.
