James is the former program director for the Palm Beach County Community Action Agency (CAA), a division of the Community Services Department. He earned a certification in the Community Action Partnership's Peer Review program which is based on the Malcolm Baldrige model and is one of six Certified Community Action Professionals (CCAP) in the state of Florida. He is a Nationally Certified ROMA (Results Oriented Management and Accountability) trainer, which is a complete management and accountability process based on principles derived from Peter Drucker and Reginald Carter.

James recently received the Florida Association for Community Action, Inc. (FACA) Agency of the Year Award on behalf of CAA for assisting the greatest number of families and individuals to achieve economic independence and self-sufficiency within their communities in 2013-2014. This award also recognized local advocacy efforts, community participation, partnerships and collaborations formed by the agency to assist low-income citizens in their journey to economic security and self-sufficiency as well as the agency's efforts to achieve organizational excellence and represent the best practices within the network.
