# IX. Standing Reports & Updates

- A. **Health Care Reform**: Geoff Downie gave a reminder that open enrollment starts November 1<sup>st</sup>. Geoff shared that at the Executive meeting, there was agreement to form an Ad hoc Committee to look at or analyze Part A's involvement in the Affordable Care Act.
- B. Legislature Updates: Vicki Krusel stated there are no updates.
- C. **CPP Updates**: Richardo Jackson mentioned the email sent out with a flyer for Faces of HIV event on October 2, 2015.
- D. Part B Report; Patient Care & 4BNWK Report: Mitchell Durant provided the ADAP/Patient Care/Preventions/Surveillance Report, ADAP Client Transition Plan and Part B Expenditure Report. Mr. Durant informed that the focus of the ADAP Transition Plan is to give the clients more accountability. Part B is somewhat behind on spending but will have a monitoring in November with the State and has assured them that money will be spent. The General Network and 4B just started in July 1<sup>st</sup>, so there's not much happening.
- E. **Surveillance Report**: Mitchell Durant on behalf of Psyche Doe provided the Palm Beach Newly Reported Adult AIDS & HIV Report.
- F. **Medicaid Report**: There is no local representative.
- G. **PBC Housing Authority—Update on HOPWA**: Mark White gave a couple of updates on the HOWPA program. (too much background noise, I could not clearly hear Mark's report)
- H. **Florida Statewide Consumer Advisory Group (CAG):** Denise St. Joy stated the C.AG. Retreat is considered a success, as there were 29 participants. Ms. St. Joy thanked everyone that supported and attended the Retreat.
- I. **Part A Report**: Geoff Downie informed that his office is working on the grant application and the data management system. Geoff announced that on October 9<sup>th</sup> Nadia, Mitchell and Psyche Doe will be presenting at the GIS Symposium @ the PBC Convention Center.

- J. Expenditure Report: Membership: Frank Frank reported on the U.S. Conference on AIDS that he and Nadia attended on September 9. Frank stated he attended a couple of meetings on the future of Ryan White there were discussion of elimination of Part D and combining it with Part C and bill proposal to cut back on funding. Base on this information, Frank suggested that we reach out to our local Congressman to keep funding because we are providing a valuable service. The grantees are now called recipients.
