Recommended Measures:

Resilience Building Index: Pre- and post-intervention resilience scores for youth and families (using RCI or similar resilience metrics).

Understanding and Awareness of Adverse Childhood Experiences (ACEs) and Resiliency: Pre- and post-program understanding of ACEs and resilience among participants.

Family Support Access Rate: Number of families accessing community-based support services.

Another suggestion was to assess "Knowledge, Awareness, Behavioral Change" using a pre and post assessment/survey to ascertain "What difference "X" has made."

Also, assess Knowledge and Access to Resources.

School District programs were shared and it was noted that perhaps we might identify alignment between mental health initiatives and school district initiatives intersect.

It was noted that this subcommittee has a more global focus than the other subcommittees, so no specific recommendations were discussed with respect to obtaining feedback and suggestions for Standards, Outcomes and Measures.

General comments included the following: Using the RCI as a measurement tool is positive as it is individually based and it also removes paternalistic attitudes because it is based on an individual's self-report.

It was recommended that we should include a comparison between local standards and national standards, inclusive of SAMHSA guidelines. Additionally, an ancillary document should be written that shows sources of generally accepted standards (i.e., evidence-based strategies).

As a qualifying county, it was also noted that we have a responsibility to be a leader and set the standard for evaluating what we implement; for example, if we are looking at national benchmarks, we should ensure we are aligning our standards as well.

Overview

First piece of business was to approve Minutes from last subcommittee meeting on August 1, 2024. Diane Jehle moved to approve the Minutes; Anita Cocoves seconded. The Motion passed.

Questions were raised regarding where to send individuals since the ASU is no longer available. Two presentations were made at the State Attorney's Addiction and Recovery (SAAR) Task Force from September 18, 2024, one by SEFBHN, the other by the Health Care District. Discussed that the after action report is still in process of being discussed between the principles and isn't ready for public dissemination yet. Discussion also ensued regarding receiving facilities as well as the fact that the Mangonia Clinic at the JFK North campus is still up and running. There are plans to expand hours of operation to make it more accessible to those in need. Mangonia and other Federally Qualified Health Centers (FQHC) will continue to offer SUD specific services. DAF is considered a Baker Act receiving facility, although it was mentioned (and dispelled) that people wait outside for admission. This was stated as being inaccurate as the only individuals who remain outside are those who refuse to go inside.

Also stated was that JFK North is within the 5% of hospitals nationwide which is inducting clients with suboxone.

On a positive note, FR reported at the SAAR meeting that this year they received the lowest number of calls since 2017.

It was noted that a receiving facility that operates 24/7 is needed and that it should make it easier for law enforcement drop-off.

Also discussed possibility of reconsidering this subcommittee as it was initiated for a specific purpose and that purpose doesn't exist anymore.
