There was a general discussion about the program.

School Safety Grant Presentation: Andrew Pollack, School Safety Grant, Board of Selection, Heather Harer, Executive Director, School Safety Grant, Lee Mandel, CEO and Owner Intralogics, and Richie Perna, Vice President, Business Development, Intralogics Mr. Pollack mentioned that he created the School Safety Grant to help law enforcement have the tools that are needed to prevent future mass violence tragedies.
