  - a. **Purpose of the Subcommittee** Director Henson advised that school safety was brought up by Erica Whitfield, CJC Palm Beach County School Board Member at the CJC Annual Planning meeting held on February 26, 2018. The CJC referred this item to the Law Enforcement Planning Council to facilitate. There was a discussion about having Bill Johnson from the Palm Beach County Emergency Operations Center participate in the committee. Chairman Martz recommended that he should attend a meeting to explain his role on the committee.

A general discussion was held about whether the subcommittee was

needed. RAC Mercurio noted that communication was a big issue during the recent incident in Broward. Chief Kitzerow recommended the FBI's Active Shooter film "The Coming Storm". He also mentioned a LEX sharing platform that was recently launched where hospitals, schools, daycare centers, etc., can upload their plans. Chief DeMario mentioned the need to identify mental health problems prior to the occurrence of an incident. Ms. Powell discussed the purpose of the Grand Jury that was recently convened. Judge Martz mentioned that it would be helpful to know the resources that are available and to have a checklist. All of the members agreed that a unified message is needed and thought that the subcommittee could enhance collaboration.
