#### A Message From The Chair

J

It was extremely gratifying to be Chair of the Palm Beach County Criminal Justice Commission (CJC) during the past year. I am pleased to present our 2004 Annual Report which highlights our activities throughout the year.

The CJC's overall mission is to provide an efficient, cost effective and timely criminal justice system to the citizens of Palm Beach County – and I can report that our activities during 2004 succeeded in forwarding that assignment.

During 2004, the CJC's committees and task forces contributed significantly to providing an efficient criminal justice system. The Law Enforcement Planning Council is working with Palm Beach Community College and Facilities Management to obtain a site for a countywide law enforcement training facility. This will be available to all law enforcement agencies in the county—a significant step forward in providing well-trained professional protection and will coordinate all applicable training with Fire Services. Through its 40-hour course, the Crisis Intervention Team program trained 111 law enforcement and health professionals to better respond to, assess and diffuse situations involving mentally ill offenders.

I am delighted to share that the work of the Law Enforcement Planning Council, Countywide Weed and Seed, Drug Court, and Truancy Interdiction Program will continue through cooperative funding partnerships. We are also working closely with the City of Belle Glade to develop its Weed and Seed initiative. The CJC's goal of making available a cost effective criminal justice system is well-represented by the advancing of these projects.

The Corrections Task Force/Public Safety Coordinating Council continued the CJC's objective of providing a timely criminal justice system. With the expertise of ISS and cooperation of the Palm Beach County Sheriff's Department, inmates are now able to meet with their public defenders though videoconference. This will save hours of travel and waiting time for both clients and public defenders, and decrease valuable jail staff time used moving inmates throughout the facility. In addition, new arrestees are now allowed phone access for local calls in the jail intake area, enabling some to bond out earlier. This measure saves time for the courts, lawyers and offenders and also allows for more appropriate use of jail space.

As you can imagine, successful undertakings of this type would not be possible without the able assistance of our 200 private and public sector volunteers – the members of the Criminal Justice Commission and our committees. My thanks go out to these dedicated people for enabling my year as Chair to move the CJC's mission forward. The Board of County Commissioners also deserves special thanks for creating and supporting the CJC, and for giving all of us the opportunity to serve the citizens of Palm Beach County.

Space does not allow me to list all of the CJC's accomplishments during 2004. I hope you will take the time to read the entire Annual Report and discover the scope of this worthwhile organization.

#### **MISSION**

The Criminal **Tustice** Commission is established to study all aspects of the criminal justice and crime prevention systems within the federal, state, county, municipal and private agencies within the county. This purpose shall include the study of the health and human services and educational systems, among others, as they pertain to criminal justice or crime prevention.



#### **HISTORY**

In August 1988, the Palm Beach County Criminal Justice Commission (CJC) was established by County Ordinance 88-16. It is composed of 21 criminal justice agency heads and 12 representatives from the business community.

The CJC was created to develop crime prevention initiatives and to affect the crime rate and its accompanying rising cost to the County. County officials and business leaders built a unique partnership when they created the CJC. The theory of government and business working as a team to solve the problems of a community was not the norm. The CJC is a statewide model for criminal justice cooperation and coordination.

Initially, the CJC commissioned a comprehensive study of the entire criminal justice system in Palm Beach County. This 1990 study resulted in almost 100 recommendations for improving the costeffectiveness and efficiency of the system. The CIC created eight task forces, including the Criminal Justice Information System, Corrections, Drug/ Alcohol Abuse Prevention, Crime Prevention, Court System, Human Services, Juvenile Justice/Education, Law Enforcement assess recommendations and develop implementation plans. The basic committee structure has evolved into its present form of over 15 committees and task forces, with the focus concentrating on all aspects of crime prevention, law enforcement, courts and corrections.

Today, the Criminal Justice Commission is respected as the forum for review of any policy, procedure, program, grant, legislation, or issue that impacts the criminal justice system in the County. Through its committee process and the dedication of professionals from a wide range of disciplines, the CJC continues to provide a necessary service to the citizens of Palm Beach County.

#### Successes of 2004

The CJC engaged in many worthwhile efforts over the past year that are too numerous to mention in this document. Suffice it to say, each of these endeavors involved great effort on the part of our members and staff. The following are highlights of what was accomplished in 2004:

#### **Byrne Grant Committee**

This year, the Byrne Grant Committee distributed more than \$637,180 to 11 agencies. Also, \$258,252 in Local Law Enforcement Block Grants (LLEBG) were distributed to two projects. Additional LLEBG funds of \$353,850 were used for two projects.

#### **Community Justice Service Center (CJSC)**

In August, our Community Court celebrated its fifth year anniversary and changed its name to the Community Justice Service Center (CJSC) which reflects its expanded mission.

This year the CJSC processed 2,151 new cases. Offenders completed 22,384 hours of community service to revitalize the community. The CJSC also responded to the need of 9,280 walk-ins who voluntarily came into the Center seeking an array of social service needs.

#### **Crisis Intervention Team Program (CIT)**

The CIT is a program to train law enforcement officers to more respond appropriately and deal effectively when coming into contact with mentally ill offenders. Four classes graduated a total of 111 police officers from over 15 law enforcement agencies in Palm Beach County.

#### **Corrections Task Force**

The Corrections Task Force was instrumental in providing free local telephone access for new arrestees and videoconferencing capabilities for inmates. The Task Force is working with the PBC Sheriff's Office to obtain access to its new database to better inform the BCC with regard to the jail population.

#### **Court System Task Force**

The Court System Task Force was asked to conduct a study on the impact of additional law enforcement officers on the criminal justice system. The study concluded that an increase in population, coupled with an increase in the law enforcement officer allocations, resulted in an increase in the number of arrests made. Assessing the implication of this study has been made a priority for 2005.

#### **Criminal Justice Education Task Force**

Over 60 citizens attended one of two 11-week Criminal Justice Academies this year. The Criminal Justice Academy was the first program featured in "Palm Beaches Extra" on Channel 20.

#### **Domestic Security Committee**

The Domestic Security Committee developed a countywide anti-terrorism standard operating procedure for all law enforcement agencies in Palm Beach County to address acts of domestic terrorism. The same committee also compiled and distributed a Current Anti-Terrorism Resource Inventory to all law enforcement agencies.

#### Successes of 2004

#### **Ex-Offender Re-entry Program**

One hundred eighty-five new applications have been received and 95 have been deemed "eligible" for services. All 95 entered the program. This year, a total of eighteen clients have successfully completed Project R.E.A.P. and 34 have successfully been employed thru the Project.

#### **Funding Allocation and Evaluation Committee**

This Committee secured a \$1 million annual funding commitment from the BCC to provide stability for CJC programs that may be in jeopardy due to cuts in federal grant allocations. The BCC agreed the funding commitment would be recurring and any unused funds may be carried over to the following year.

#### **Gun Safety Initiative**

The Task Force distributed over 200 gun locks and 2,000 gun safety videos at the Palm Beach County Fair and the National Night Out Against Crime event. On "Locks to Cops Day," 2,000 gun locks and 2,000 personal gun safety records pamphlets were distributed to local law enforcement agencies to disperse to their residents.

#### Law Enforcement Planning Council (LEPC)

The LEPC is moving forward in obtaining a law enforcement training facility that will be used by all law enforcement agencies in the county. In keeping with its mandate to improve coordination and cooperation among law enforcement agencies in Palm Beach County, the LEPC reviewed, revised and renewed the current Palm Beach County Mutual Aid Agreement, which permits voluntary cooperation and assistance of a routine law enforcement nature across jurisdictional lines, as well as providing for the rendering of assistance in a law enforcement emergency.

#### **Legislative Issues Committee**

This committee educated local legislators on the potential effect of HB155, which is a bill that addresses Firearm Records. As a result, the bill was substantially amended in favor of law enforcement.

#### Visual Planning Technology (VPT)

The BCC approved \$499,900 for the development and deployment of a system to integrate disparate judiciary and law enforcement information systems. This will include the VPT pilot project which will take approximately six months to implement..

#### Weed and Seed Program

The Weed and Seed Steering Committee has successfully supported and advised four active sites. The Evaluation Subcommittee developed a uniform outcome reporting system which will highlight the sites' successes individually and countywide.





The Criminal Justice Commission (CJC) was created by the Board of County Commissioners (BCC) in 1988 to study and advise the BCC on all issues related to the health and safety of Palm Beach County residents.

The CJC is composed of 21 public agency executives and 12 private sector business and educational leaders. The CJC accomplishes its Mission by utilizing the talents and expertise of these 33 individuals and their diverse backgrounds to research and collaborate on emerging criminal justice issues in Palm Beach County.

We congratulate the CJC for its many accomplishments this past year. Naming a few would include the Crisis Intervention Team training being provided to law enforcement officers in Palm Beach County. The CIT program trains officers how to deal more effectively with mentally ill offenders. The Criminal Justice Education Task Force graduated 60 citizens from the two 11-week Citizen's Criminal Justice Academies designed to educate citizens on how the justice system functions in Palm Beach County. The Gun Safety program promotes responsible gun ownership by distributing thousands of free gun locks and gun safety videos to help protect our children from injury and or death from unlocked firearms.



#### FROM THE EXECUTIVE DIRECTOR

2004 ended on a very difficult note with weather conditions that disrupted and affected many of us in different ways. In spite of this, I am proud of the accomplishments we were able to achieve with your continued support and involvement. The CJC is truly a collaborative effort involving both public and private sector individuals dedicated to improving the local justice system, thereby improving the quality of life for all citizens of Palm Beach County.

As we review the list of accomplishments under the leadership of Chair Wendy Link, I realize they are too numerous to mention. I will single out but a few for recognition.

The Byrne Grant Committee once again performed admirably by reviewing funding proposals and distributing more than \$637,000 to 11 separate agencies. In addition, Local Law Enforcement Block Grants, whose federal allocation to Palm Beach County was cut by more than half, still disbursed over \$250,000 to fund two projects.

Community Court celebrated its fifth complete year of operation and officially changed its name to Community Justice Service Center. Research continues on the possible expansion of a Community Justice Service Center to a second location in a CCRT area located in the unincorporated area of the county.

In 2004, the CJC is also pleased to have introduced the Crisis Intervention Team training to law enforcement officers throughout the county, through which officers are learning how to more effectively deal with mentally ill offenders. It has been estimated that as many as 17% of the offenders entering the justice system have a mental disorder that requires specialized handling. We salute the many mental health professionals who contribute their time to provide this valuable training to law enforcement.

The Domestic Security Committee, made up of local law enforcement professionals, developed a countywide anti-terrorism standard operating procedure for all law enforcement agencies in Palm Beach County to address acts of domestic terrorism. The same committee also compiled and distributed a current Anti-Terrorism Resource Inventory to all law enforcement agencies.

Programs initiated by the CJC require start-up funding until a permanent home for them is identified. The Funding Allocation and Evaluation Committee was able to provide program security for a number of existing programs and staff and for the future by obtaining a \$1,000,000 annual funding commitment from the Board of County Commissioners.

In addition to these, other equally significant accomplishments are listed in this annual report. It has been estimated that over 200 dedicated individuals volunteer their time and efforts annually to the CJC. It is the culmination of these efforts that results in the many successes of the CJC. I wish to take this opportunity to thank these unnamed individuals for the many hours they have invested in projects that improve the criminal justice system in Palm Beach County.



# Funding Allocation & Evaluation

#### **2004 Accomplishments**

- Monitored anticipated fiscal impact of Article V/ Revision 7 on local criminal justice system initiatives.
- Met with substance abuse and mental health funders to determine if funding could be obtained to support substance abuse and mental health treatment for CJC programs.
- Participated in June 2 and July 14 BCC budget workshops to determine BCC program funding priorities.
- Secured a \$1 million annual recurring funding commitment from the BCC for CJC programs -Law Enforcement Planning Council Countywide Weed and Seed Coordinator Drug Court Clerical Specialist Countywide Truancy Interdiction Program Coordinator Belle Glade Weed and Seed Initiative Byrne Grant Local Match
- Reviewed and approved \$120,000 to fund Weed and Seed operations for Belle Glade from the \$1 million BCC funding commitment.
- Reviewed and approved a funding request from the Comprehensive Alcohol Rehabilitation Program (CARP) for a one-time, non-recurring allocation of \$108,531 to support the Homeless/Substance Abuse Residential Program administered by CARP.



After securing FY05 funding for CJC programs, the Committee was sunset on October 8, 2004. An Evaluation Committee was created to review program evaluations conducted by staff.

### **Gun Safety Initiative**

#### **Purpose**

To promote gun safety initiatives and distribute gun safety locks throughout Palm **Beach County** 

#### 2004 Accomplishments

- Over 200 gun locks and 2,000 Gun Safety videos were distributed to the residents of Palm Beach County at the South Florida Fair and through local law enforcement agencies for their National Night Out Against Crime activities.
- Over 2,000 Personal Firearm Safety Pamphlets were distributed to residents in Palm Beach County. They were created by the federal Bureau of Alcohol, Tobacco, Firearms and Explosives for lawful firearm owners to record their personal firearms information on this pamphlet, so in the event their firearms are ever stolen they will have a full description to provide to police. These pamphlets were created to assist law enforcement in returning recovered stolen firearms to their lawful owners.

• Held "Locks To Cops" event through which 2,000 gunlocks and 2,000 Personal Firearm Records

were distributed to local law enforcement for use by residents they encounter during their patrol.

#### 2004 Accomplishments

- Educated local legislators on the potential effect of HB155 with regards to Firearm Records on law enforcement. The bill was substantially amended in favor of law enforcement
- Corresponded with the State Legislators on eight (8) pieces of proposed legislation advising them on the effects on the criminal justice system and the position of the Criminal Justice Commission:

### **Truancy Interdiction Program**

#### **Purpose**

To coordinate the five Truancy Interdiction Program Centers to foster: consistency in operation of all TIP Centers; the development of resources to meet the needs of the truants and their families; the cooperation and collaboration between law enforcement agencies, the school system, other community agencies; and to ensure the major goals of the program are promoted

#### 2004 Accomplishments

- Garnered support for and received a grant from the Department of Juvenile Justice to provide case managers at three TIP centers; which will provide services to 200 truants and their families in the 04/05 school year
- Provided case management services to 52 children in the 03/04 school year



- Facilitated the utilization of the same database by all five TIP Centers enabling the data to be collated and analyzed more efficiently and consistently
- 2,434 truants were processed through the TIP Centers in the 03/04 school year, all programs showed an increase, the most significant increase in the Belle Glade Center
- 23 law enforcement agencies utilized the TIP Centers, involving students from 115 different schools
- Training for law enforcement has been developed
- Organized monthly meetings for staff from all five TIP Centers to exchange information and develop strategies to improve the program



#### 2004 Accomplishments

- Coordinated and hosted <u>Expanding the Counter-Terrorism Intelligence Base Among the Middle Eastern and Muslim Community in Palm Beach County</u>.
   Speakers discussed ways to increase intelligence gathering with 34 law enforcement personnel representing 20 agencies.
- Formed a 2004 Presidential Election Security Task
   Force to develop a strategy and plan for local security during the 2004 Presidential elections.
- Updated and distributed a 2004 Anti-Terrorism Resource Inventory to all local law enforcement agencies.
- Thirty-four agencies participated in a Communications Interoperability Drill to utilize existing mutual aid communications resources and discover the capabilities of agencies to establish electronic voice communications at a location within Palm Beach County.
- Initiated weekly communications tests of the Public Safety Answering Point's (PSAP) equipment and procedures.
- Held a training session for 30 participants on using the Emergency Deployable Interoperable Communications System (EDICS) and Mutual Aid Communications (MAC) units for law enforcement personnel and technicians.
- Supported Region 7 information sharing initiative with letters of support from the Committee.
- Coordinated information sharing among local law enforcement.

### Visual Planning Technologies

#### **Purpose**

To create a countywide criminal justice data sharing network which will facilitate the sharing of criminal justice information at all levels of law enforcement (local, state, federal). The long-term goal of the project is to increase the efficiency of law enforcement.

#### **2004 Accomplishments**

- SEARCH, the National Consortium for Justice Information and Statistics, conducted a 3-day site visit and issued a Technical Assistance Report with comments and recommendations.
- Project staff assisted the Sheriff's Office,
   Department of Corrections, and the School
   District police to improve the tracking of sexual predators.
- Workgroup sessions with representatives from
   12 law enforcement agencies are identifying the

specific needs of road patrol and investigative users.





- The Board of County Commissioners funded the JIS VPT pilot project in the amount of \$499,900.
- The implementation of the pilot project to link six agencies began in December and is projected to be fully operational by mid-2005.

   now has 11 member municipalities.
- The radio system will be implemented in two phases. The Cities of West Palm Beach, Palm Beach Gardens and Palm Beach will be in phase one.



George Elmore CJC Liaison

- Financing negotiations for phase one have been ongoing. The final agreement necessary for the financing is now being reviewed by the city attorneys for the phase one cities.
- The MPSCC is preparing for final contract negotiations to begin with MACOM as soon as a financing plan is approved.
- Work on the system is expected to begin

in mid-2005 and the system is anticipated to be operational countywide in 2006.
