I. Welcome - Meeting was called to order at 12:10pm. The Co-Chairs presided, Barbara Cheives, and Chief Sarah Mooney. Guests were introduced.

II. **Approval Agenda & Minutes**

A. **Community Engagement Supplemental Grant**

Kristina Henson shared that we received \$150,000 of the \$200,000 two year grant. A Grant Adjustment Notice (GAN) will need to be submitted to include the Implicit Bias Training and Race Equity Institute Training. All of the GANS reflect categories discussed in early February.

B. **Update on San Castle**

Houston Tate was introduced and clarified some of the important community work that has taken place in San Castle. Some of the actions include installation of speed bumps, tiny libraries, community gardens, food pantries, and a strong infrastructure program. He mentioned that the community needs support to create internships and other opportunities for youth.

There was a discussion about an event in San Castle. Staff will work on planning a date for April, perhaps coinciding with a regularly scheduled event in San Castle.
