- VI. Presentations/Update
 - a. Barbara White, Chief Assistant Public Defender, provided information about the electronic subpoena service that was developed in 2013. She reviewed some of the advantages of the system and noted that there are currently four agencies utilizing the system. A handout was provided that listed the advantages and procedures of the system. She also noted that she will be retiring at the end of April. Scott Penney should be contacted after April 30th.

IX. Liaison Updates

- a. Data Sharing: Chief Kitzerow reported that LEX is back up and running. He noted they have more data contributors now. Ted Gonzales will continue as the Program Director and Retired Chief Dennis Weiner will be the Executive Director of LEX. They are currently in the pilot stage of the ALPR system.
- b. Community Engagement Task Force: Chief Mooney reported that the next community conversation will be held tonight at 6 pm at the Tabernacle Baptist Church. Information was provided to attendees.
- c. SART: Report is attached.
- d. State Attorney's Office: Chief Investigator Bill Fraser asked that law enforcement contact the SAO in the event of a juvenile involved shooting before making any arrests. He advised that threats on social media need to be vetted with the SAO since there are specific rules that apply to those situations. There was a discussion about school safety. RAC Mercurio noted that school threats are being tracked through the FUSION Center. Chief Kitzerow provided an overview of recent discussions about school safety in Tallahassee with Governor Scott. He noted this issue is a top priority for the state. There is support to ensure that every school has a resource officer. A cooling period is needed where weapons will be held for a certain period of time. He recommended that a minimum a CPTED should be prepared for schools. He also noted the importance of staff understanding the State Attorney Aronberg advised that it was reunification process. announced today that a grand jury will be convened to examine school safety and make recommendations for Palm Beach County. He noted some of the limitations with current legislation including the self-reporting requirement. Major Chandler mentioned that they have the ability to forensically map schools. He offered this service for any agency that may need it for future events. Chairman Jenkins commended Palm Beach County Schools for their efforts.
