- I. Welcome and opening comments by Chief Richard Jenkins, Chairman.
 - a. Congratulated Chief Frank Kitzerow on his appointment as the Chief for the Palm Beach County School District Police Department. He also welcomed Chief Michael Gregory of the Boynton Beach Police Department.

- V. Presentations/Update
 - a. **Hurricane Season Update and Lessons Learned:** Bill Johnson, Director Emergency Management, provided information about the transition of staffing from the Red Cross to Palm Beach County noting that 450 employees have been trained to assist in shelters. He discussed new procedures that have been implemented to speed up registration and identification including

the issuance of wristbands. They have also been working with media to educate the public about shelter accommodations and when it is necessary to evacuate. Chairman Jenkins thanked Mr. Johnson for his presentation and suggested that notifications be issued well in advance via text rather than email. He also requested that only law enforcement be included on calls. Several Chiefs voiced their concerns about curfews that involved checkpoints. They suggested curfews be issued only for barrier islands.

- b. **Training Symposium on School Safety:** Judge Martz provided an update about the School Safety Subcommittee and an overview of the symposium. The intent of the symposium is to provide a venue for the lead trainers to share their ideas and to make sure everyone is on the same page. There was a discussion about the scope of the symposium. Judge Martz confirmed that the intent is not to develop policy, but to share best practices. LEPC agreed that the event should focus on best practices.

 - a. **Data Sharing:** Chief Brian Smith has agreed to Chair LEX. Dennis Weiner, Executive Director, Law Enforcement Exchange noted that the ALPR and Rhodium are in full production. Currently they have 30 licenses, but they can purchase more if needed.
