XII. Training Announcements

- a. FCADV, with co-sponsor the Domestic Violence Council of Palm Beach County, is holding a one day training institute for advocates, lawyers, child welfare workers, court personnel and others to increase community collaboration and improve system response to combat domestic violence. Plenary speakers are Dr. Neil Websdale, Professor of Criminology at Northern Arizona University and Director of the National Domestic Violence Fatality Review Initiative, who will speak on national trends in fatality review; and David Mandel who has been working in the domestic violence field for over 20 years, and will speak about the Safe and Together Model on improving responses to domestic violence when children are involved. The training institute will include afternoon breakout sessions with Dr. Websdale on factors indicating increased danger to domestic violence victims; Mr. Mandel on improving services to victims and increasing batterer accountability in the child welfare system; attorney Michael Dulce on the Power of Civil Relief for Crime Victims-how the resources of the civil justice system can support the criminal justice process to best help the victims restore their lives; and Assistant State Attorney Elizabeth Parker and Sergeant Kyle Haas, supervisor of the Domestic Violence/Victim Witness Unit, Palm Beach County Sherriff's Office, on building the strongest case, from 911 call to trial, including prosecuting without the victim. **Date: Thursday, October 14, 2010 - 08:00 Venue: Crowne Plaza Hotel 1601 Belvedere Boulevard West Palm Beach.**
