- c. Wished Director Larry Schroeder the best and welcomed Interim Director Jill Reiter of the Criminal Justice Institute Palm Beach State College.

- IV. The minutes of the November 10, 2016 meeting were approved.
- V. Presentations
 - a. Chief Richard Jenkins, Vice-Chairman and Kristina Henson, Executive Director of the Criminal Justice Commission recognized the Village of Palm Springs, Village Manager Richard J. Reade and Palm Springs Police Department, Chief of Police Thomas Ceccarelli for outstanding service to the Law Enforcement Planning Council.
 - b. Tim Ratty, Chairman of the Board for the Palm Beach County DeGeorge Boys & Girls Club and Victor Rivera provided information about how the Boys & Girls Club has impacted the community. They mentioned the need for volunteers and Board members.
 - c. Criminal Justice Commission Updates: *Kristina Henson, Executive Director of the Criminal Justice Commission*

Kristina Henson thanked everyone for their support of the application. She advised that the Criminal Justice Commission wasn't awarded the grant.

ii. CJC's Body-Worn Camera Committee

Kristina Henson advised that the first meeting was held on January 11, 2017. Chief Kummerlen provided a demo of the West Palm Beach Police Department's system and shared their experiences in setting up a program. Vice-Chairman Jenkins noted that he was pleased with the meeting. He also mentioned that concerns voiced at the last meeting were addressed.

iii. Legislative Update

Kristina Henson referred to the 2017 legislation update in the meeting packet. She also noted the rental car legislation.

iv. Opioid Epidemic/South Florida HIDTA Overdose App – Kristina Henson, CJC Executive Director and Alain J Roque, South Florida HIDTA

Kristina Henson provided information about a countywide effort to address the opioid epidemic. She mentioned that Marci Ronik and Julie Radlauer of the Ronik-Radlauer Group, Inc. are working on a needs assessment that will be presented to the Palm Beach County Board of County Commissioners. Mr. Roque presented information about the ODMAP app that can be run on the desktop or smart phones. There are two categories to track overdoses (fatal and nonfatal). ASAC McKenna mentioned that they also have a tracking system to track supply and distribution. Chief Assistant Fernandes mentioned a bill that includes fentanyl under the trafficking statutes. Also, the need for a fully funded drug court.

 - b. Community Engagement Task Force: Chief Kitzerow reported that the next meeting will be held on January 27th at the Salvation Army at 10 AM.
 - c. Sexual Assault Response Team: Nicole Bishop passed out the revised protocols that reflect statutory changes. She thanked Chief Jenkins and the State Attorney's Office for their assistance.
 - d. Child Abuse Protocol: The next Specialist meeting will be held on Friday, February 10th at 9 AM in the West Palm Beach Police Department's Community Room.
 - e. Criminal Justice Institute: The next law enforcement graduation will be on February 23rd.
 - f. Communications/Interoperability: Nothing new to report
 - g. State Attorney's Office: Chief Assistant Brian Fernandes discussed concerns about SB128 regarding self-defense immunity. This bill would shift the burden of proof in self-defense cases from the defendant to the state/prosecutors, and provides that the state must prove its burden by the "beyond a reasonable doubt" standard. This will make it extremely difficult to charge homicide defendants who claim immunity based on a justifiable use of force.
