- VI. Chairman's Comments
 - a. Wifredo A. Ferrer, United States Attorney for the Southern District of Florida, will hold a Law Enforcement Coordination meeting during the Countywide LEX Intelligence meeting.
 - b. Welcomed Senior Supervisory Agent Stephan Robinson of the Internal Revenue Service and best wishes to George Sanders.
 - c. Reminded everyone about the Florida Police Chiefs Association Summer Conference Planning Meeting tomorrow at 10:00 a.m. at 6500 Congress Avenue in Boca Raton.

VII. Presentations

TrainU Law Enforcement Edition Training Web Site: Officer Frank Fanelli, Palm Beach County School District Police Department Training Unit

TrainU is an online training program that supplements training provided by each agency. It was developed out of a need identified by the Chiefs of Police Association to provide training at the command level. The Chiefs also wanted to provide training for their officers and those who are busy without leaving their office. Anyone can access it using their agency's code. It follows FDLE guidelines so that you can get credit and print certification of completion for the mandatory training. Officer Fanelli requested assistance and cooperation from all the agencies in getting together subject matter experts to create online content. His vision is to make Palm Beach County a

center for training and provide training opportunities for everyone no matter where they are by bringing the training to them.

Chairman Alexander thanked Officer Fanelli and noted they will send out contact information via email. Chief Kitzerow commented on the high quality of the videos and encouraged everyone to check it out. He also commended Officer Fanelli and the School Police for a job well done.

VIII. New Business

a. Drinking Compliance Program: Chief Richard Jenkins and Jeff Kadel, Executive Director of the Palm Beach County Substance Awareness Coalition

Chief Jenkins provided background information concerning the funding cut several years ago at the state level for drinking compliance and the impact on compliance checks. He remarked that Jeff Kadel came up with an innovative way of funding and training agencies. Mr. Kadel advised that he has funds for at least 6 police departments to send a 2-person team for a couple of hours of training. He can also fund eight hours of compliance check special detail for each of those 6 communities. In return, he would just like to get back data on how many compliance checks were done, and what were the results. They will follow up with a letter thanking the establishments that were in compliance, and provide training to those that were in violation. If successful, he has the funds to do it twice this year, and twice again next year.

- IX. Old Business: No old business discussed.
- X. Committee/Workgroup Reports
 - a. Book and Release Committee: Chief Pruitt reported that the committee met this month. The average daily jail population, book and release, juvenile detention center population, and misdemeanor probation population had steady declines in the past few years, with the pretrial services way up and in-house arrest remaining steady. Chief Pruitt said he will email the information to everybody. He also said that Chief Judge Colbath advised the committee that Governor Scott has requested 11 new judges statewide in his budget, and that Palm Beach County will get two new judges one circuit and one county.
 - b. Recruitment and Retention Committee: No report was presented.
 - c. Sexual Assault Response Team No report was presented.
 - d. Court Systems Task Force: No report was presented.
 - e. Sex Offender Population: Chief Pruitt reported that there was no meeting this month.

f. Traffic Committee: No report was presented.

XI. Liaison Updates

- a. Data Sharing: Chief Kitzerow reported about the LEX presentation at the CJC Annual Planning Meeting which was well received, and they are looking forward to continued funding and support. The LEX Countywide grant funded Director position has been advertised. West Palm Beach Police Department is scheduled to be added to FINDER in March. They are in the implementation phase for Delray, Riviera, and Boynton Beach. Chief Kitzerow asked anyone with a problem with the CI system to let him know or contact Denise or Penny.
- b. Child Abuse Protocol: Chief Scheller reported that the Specialist meeting was held on February 14th. He mentioned that attendance could be improved. The next Oversight meeting is scheduled for March 12th to review the Child Abuse Protocol.
- c. Criminal Justice Commission: No report was presented.
- d. Criminal Justice Institute: Director Schroeder reported 4 law enforcement, 1 corrections, and 1 dispatcher academy in progress. He asked Chiefs that are thinking of hiring to call the institute so they have an idea of how many seats will be needed.
- e. High-Intensity Drug Trafficking Area: Colonel Stormes announced that the executive board meeting will be next week.
- f. High School Criminal Justice Academies: No report was presented.
- g. Communications/Interoperability: Chief Mangold reported that an informational presentation was made to several south county chiefs about a week and a half ago. He thinks it was well received and he was hopeful for a continued discussion with South County. In addition, they met with West Palm Beach administration staff and their radio team on Tuesday to iron out all issues related to the new interlocal agreement which will be brought before the city commission on March 17th.
- XII. Training Announcements: No announcements were made.
- XIII. Member Comments: Chief Yannuzzi provided information concerning the event schedule for the 2014 Law Enforcement Torch Run for Special Olympics. Tip-a-Cop will be held on March 27th at 3 different Duffy's locations which are listed on the attached flyer. The 5k Run will be held on April 2nd starting in Lantana. Participation is appreciated from runners, and also for specialty vehicles, bicycles, motorcycles, etc. to provide additional security. He also reminded everybody about the ASIS Law Enforcement Appreciation Luncheon in May, and encouraged

agencies to submit applications and nominations for awards. April 15th is the deadline for applications. The 17th Annual Tour de Force is a 250 mile bike ride for families of law enforcement officers who were killed in the line of duty. It will be held on April 7th -11th.

Glen Wilner, Assistant Chief, U.S. Marshals Service introduced Amos Rojas, Jr., a new United States Marshall presidential appointment for the Southern District of Florida. Chairman Alexander welcomed U.S. Marshall Rojas.

Chairman Alexander reminded everyone about the law enforcement sensitive meeting after a 10 minute break.
