- V. The minutes of the meeting of March 24, 2016 were approved.
- VI. Member Highlight
  - a. U.S. Immigration and Customs Enforcement/ Homeland Security Investigations: *Acting Special Agent in Charge Robert Hutchison*

Assistant Special Agent in Charge Eddie Thompson introduced the speaker, Acting Special Agent in Charge Robert Hutchinson. Mr. Hutchinson provided a brief history about their office. Their focus is on transnational criminal organizations to stop them from getting into our country, and from going out. They work closely with border patrol, airports and seaports, DEA, FBI, foreign countries, etc. They have 74 offices in 48 countries. Locally, in Miami, they work mostly on money laundering, smuggling (drugs, weapons, and alien), and human trafficking. They also work a lot of customs frauds, stopping counterfeit (auto parts and drugs) from coming in. They focus on gangs, specifically foreign-born gang members who have illegal status here, and deport them. In addition, they work child porn and child exploitation, and basic immigration cases.

b. Florida Department of Law Enforcement: Resident Agent in Charge Duane Little

FDLE's mission is to promote public safety and strengthen domestic security by providing services to local, state, and federal agencies. RAC Little shared their organizational chart which shows the five FDLE divisions. They have seven regions, with crime labs in some of the offices. They conduct multijurisdictional criminal investigations in the criminal justice investigative side. They focus on major drugs, violent crime, public integrity, domestic security, and cyber crimes. They run forensic evidence from law enforcement through the state's DNA database. They also provide background criminal history checks in the state of Florida. In the professionalism side, they promote competency and professional conduct of Florida criminal justice officers. They provide security for the state capital complex and protect the state government's first family and other visiting dignitaries. They get their power from Florida statute 943.

## VII. Update

- a. Criminal Justice Commission: Kristina Henson, Executive Director of the Criminal Justice Commission
  - National Reentry Week The Department of Justice designated this week as National Reentry Week for the first time ever. On average, there are 98 people returning from state prison to Palm Beach County every month. Palm Beach County has a very robust reentry program which has been active for several years. The primary goal of the program is to get people jobs as they come back to Palm Beach County. They have a DOC transition facility in Pahokee called Sago Palms, where people returning to Palm Beach County can serve their last year while working with counselors and other services to assist them with integration back into the community.

- Community Engagement Task Force Provided an update about the new Criminal Justice Commission initiative voted on at the Annual Planning Meeting in February, co-chaired by Chief Kitzerow and Barbara Cheives. The goal of the committee is to bridge the gap between criminal justice agencies and the community. They had the first meeting a couple of weeks ago. One of the things the committee decided to do is take an inventory of what is happening in community engagement as it relates to criminal justice agencies. They are currently working on a survey to send out to law enforcement and other criminal justice entities to determine what type of activities are happening in the community.
- MacArthur Foundation They received a planning grant last year to look at reforms in our system related to how we use our jail. Another planning grant was awarded this year to go forward with two priorities: 1) To divert the mentally ill or the "frequent fliers" in our jail who come in and out of the jail system; 2) To look at reforming first appearance hearings to make them more risk-based. They will be working with the Pretrial Justice Institute to have technical assistance to work with the judges, prosecutors, and public defenders to figure out how to implement a risk-based assessment. This assessment will be used to look at the people who are going to first appearance hearings, so the judges will be able to make a more informed decision about releasing them based upon the risk they pose to the community.

#### VIII. New Business

a. Vice Chairman Leon announced the May LEPC meeting date change from May 26 (Thursday) to May 25, 2016 (Wednesday), at the same venue.

Director Schroeder also announced the Region 12 Council Training meeting will coincide with the LEPC meeting date change. Chief Ceccarelli noted that the meeting will be held in the same building, but a different room.

IX. Old Business: No old business discussed.

## X. Liaison Updates

- a. Data Sharing: Ted Gonzales, LEX Countywide Director reported that Boynton Beach is currently in Q&A. They are also making great strides in Tequesta in getting their system and service set up. MOUs were received from the FBI and they are working with US Customs and DEA on getting MOUs established. They are very close to over a thousand users for the month. He expressed thanks for everyone's help and support.
- b. Sexual Assault Response Team: Chief Jenkins referred to the attached SART report.

- c. Recruitment & Retention Committee: Chief Duncan Young was not present to give the report, but Vice Chairman Leon referred to the attached survey.
- d. Criminal Justice Institute: Director Schroeder reported that the law enforcement and 911 academies are graduating on May 12th. The next law enforcement academy will begin on May 26th. Corrections (full-time) and cross over (day & night) academies will begin in July. The next equivalency training will also be held in July. In addition, they are doing an online 911 course. Next week is the CJSTC meeting at the Harborside Hotel in Jupiter.
- e. Communications/Interoperability: No report presented.
- f. State Attorney's Office: Chief Assistant State Attorney Brian Fernandes announced Operation Fresh Start which deals with outstanding non-violent misdemeanor warrants. They have reduced the outstanding warrants so far by 10,000 (starting from 30,000 to 20,000) outstanding warrants, specifically through Chief Assistant Adrienne Ellis. They are doing a full day on Saturday at Gun Club and south county, with about 10 prosecutors, Clerk's Office, defense attorneys, and PBSO. Mr. Fernandes also talked about the Sober Homes problems, and Chief Assistant Alan Johnson elaborated on the issue. They will be forming a Task Force that will be starting on July 1st. Mr. Johnson asked any agency interested to contact him.
