#### a. PBC Drug Trends and updates from the Coalition

Jeff Kadel, Executive Director of the Palm Beach County Substance Awareness Coalition, talked about the success of their programs, projects, and strategies made possible with their partnership with the law enforcement agencies, which include: 1) Prescription drug drop-box program – the county currently has 24 drop-boxes, the most for any county in the country, with over 8,000 lbs. of prescription drugs collected. Jurisdictions that do not have one yet may request a drop-box for free, as donated by the solid waste authority; and 2) Underage drinking prevention through compliance checks; especial thanks to North Palm, West Palm, Palm Springs, and Palm Beach County Sheriff's Office. The Coalition provides ongoing training. Executive Director Kadel thanked agencies for their support and encouraged more participation. Katherine Hatos will send out a copy of the drug trends report. They are working on a community action plan to address the issues with flakka which includes a survey that will be sent out to agencies regarding training.

#### b. Judicial Procedure for Destruction of Evidence

Alan Johnson, Chief Assistant State Attorney of the 15<sup>th</sup> Judicial Circuit, mentioned the new Administrative Order signed by Chief Judge Colbath in June regarding the destruction of drugs, and fish and wildlife evidence. Three key points: 1) The order request has to be made by the attorney, not the evidence custodian; 2) Do not set the destruction date until the order is back from the Chief Judge or Administrative Judge; and 3) Make sure that the evidence custodians look for co-defendant cases, because of pending court cases.

#### c. Civil Citations

Helene Hvizd, Senior Assistant Palm Beach County Attorney, said that at a meeting of the Board of County Commissioners on June 23rd, staff was tasked with the responsibility of investigating the potential for an ordinance that allows a civil citation in cases of possession of small amounts of marijuana or drug paraphernalia. Legally, their investigation started with the fact that they are not preempted by state law to enact such an ordinance. Under certain circumstances, one of them is that the penalties must be lessor

than the penalties imposed by state law; and secondly that discretion is not removed from the officer. They are looking at a few models including Miami-Dade and Hallandale Beach which have already enacted ordinances. A misdemeanor crime may require more than a civil citation in certain circumstances (ie possession is incurred at the time of a felony crime, DUI, domestic violence). Civil citation wouldn't be available for those on probation, pre-trial release, or service of a search warrant. Their initial discussion revealed that there is a juvenile first offender program that is working well. Ms. Hvizd mentioned that this civil citation may not be restricted to an age group.

There was a lengthy discussion concerning this item. Chief Leon noted that this proposal cannot be used for juveniles as PBC has approved the JFO diversionary program not civil citation. Mr. Johnson agreed and added that the problem with civil citation for juveniles is that it doesn't include a treatment component. Chairman Blouin mentioned that law enforcement is very comfortable with the current JFO program. It has been very successful and the program is a lot more involved with juveniles than civil citations. In terms of civil citations for adult offenders, Chairman Blouin mentioned several issues including search incident to arrest, discretion related to totality of the circumstances, and enforcement for those that don't pay. Chief Alexander mentioned dealing with the root issue in terms of legislation. He also expressed concern about further complicating law enforcement responsibilities and increased public scrutiny. Chief Kitzerow said that the IFO model is an example for the entire state. He also expressed agreement about changing legislation rather than writing ordinances to bypass them and inquired about the desired outcome of civil citations. Ms. Hvizd responded that those who approached the BCC presented concerns for the juveniles that may not be able to satisfy some of the penalties or restrictions imposed by the JFO, and also adults who may be charged and end up with a criminal record. Chairman Blouin contended that the JFO program completely removes the offense from their record while civil citations would remain on the offender's record. Chief Leon talked about the improvements to the program over the years. Ms. Hvizd asked if she may approach Chief Leon for additional information and potentially for a meeting with the Commissioners. Sheriff Bradshaw mentioned that he didn't think that all of the Commissioners were in favor of civil citations. He mentioned that there are already diversionary programs in place. He also advised that the Deputies will go by the current system. Chief Judge Colbath mentioned that the preliminary investigation for another project revealed that there are very few people that would qualify for civil citations.

#### X. Liaison Updates

- a. Sexual Assault Response Team: Chief Jenkins referred to the attached SART update. He discussed the lethality screening for first responders from Oklahoma City Police Department that's been used effectively for the last several years in reducing domestic violence, serious injuries for victims, and domestic violence murders. Next month they will have an draft accreditation compliant policy attached to the agenda for agencies to determine if they would like to voluntarily adopt the policy.
- b. Data Sharing: Chief Kitzerow reported that the numbers for LEX continue to climb as more officers are being trained in the new system. He thanked Ted Gonzales and the LEX staff for all their hard work. He also thanked the Criminal Justice Commission for another year of funding for the countywide operations director position. He asked Mike Rodriguez to thank the Criminal Justice Commission for their continued support. Regarding other agencies contributing to LEX: Highland Beach, Tequesta, and Ocean Ridge are on the implementation phase and working on connectivity throughout the county network. Still in the planning phase are Palm Beach Shores and Lake Clarke Shores. They will be meeting this month with the State Attorney's Office to integrate them into the LEX system. Training on the new 3.0 LEX continues throughout the county. Schedules are underway and being well received by: Town of Palm Beach, North Palm Beach, West Palm Beach, Juno Beach, Delray, Jupiter, and Palm Beach Gardens. LEX board meeting is scheduled for September 3<sup>rd</sup> at 2:00 at the Vista Center.
- c. Criminal Justice Institute: Director Schroeder reported that they have a number of academies: one starting this past Monday, one starting on the 8<sup>th</sup>, one on October 19<sup>th</sup>. They have several graduations coming up towards the end of September and end of October. They are offering the SART training at the officer level at the college on September 29<sup>th</sup>. They increased their allocations on the equivalency training from 12 to 24 to meet the demand. Chairman Blouin asked about the number of cadets that are generally in each category. Director Schroeder said that they normally have an average of 33 cadets or above for full time; but that the part-time is a struggle with higher attrition. Part-time is currently at 20. Maximum capacity for each class is 36.
- d. Communications/Interoperability: Chief Mangold reported that the WPB P-25 overlay on the MPSCC open sky countywide network is moving forward, on schedule, and no glitches at this point.
