V. Approval of the minutes of the meeting of July 24, 2014

The minutes of the July 24, 2014 meeting was approved.

#### VI. Chairman's Comments

a. Chief Alexander congratulated Chief Anthony W. Strianese of the Delray Beach Police Department on his retirement and presented him a small token of appreciation for his years of dedicated service to the LEPC.

#### VII. Presentations

a. Criminal Justice Information Services (CJIS) Update: *Michael E. Gargiulo, CJIS IDT Trainer of the Florida Department of Law Enforcement* 

Michael Gargiulo provided background information on his duties as the region's CJIS IDT Trainer. He also talked about recent changes in CJIS including:

- CJIS has a new director, Jennifer Pritt
- CJIS FCIC/NCIC certification was split into limited and full access.
- FBI will be coming to Florida in Spring of 2015 to conduct an audit
- Other important issues:
  - o Security awareness training for anyone who reads criminal histories;
  - Provided information about the Falcon system database including rapid
     ID function and retained applicant fingerprints submission;
  - o DL photo share (currently offered by about two-thirds of states);
  - DAVID- moved to the internet in the summer and may now be accessed by cell phones. Joni Livingston noted that with DAVID now being a webbased application it is more accessible and therefore more susceptible to abuse. She also emphasized the importance of training sessions against electronic database abuse.
  - o Recent CJIS memo within DAVID and FCIC regarding emergency contact information which cannot be used for investigative purposes.
- b. 2-1-1 Palm Beach/Treasure Coast: Sharon L'Herrou, Director of 2-1-1 Programs and Services

2-1-1 is a hotline and helpline with the vision of having the community get the information they need. Sharon L'Herrou talked about the different services and programs provided by 2-1-1, its benefits, and the important role it plays in the community. Services provided by the 2-1-1 call center include a 24/7 hotline manned by live persons; information assessment and referral; and phone counseling (crisis intervention, suicide prevention, and advocacy). In addition to the to the call center, 2-1-1 provides other programs such as: a) Elder Crisis Outreach; b) Sunshine Telephone Program; c) Special Needs Helpline; and d) Healthcare Advocate.

In taking calls from the community, 2-1-1 is in a unique position to see where the needs are and therefore create programs to fill the gaps in services. And as the front door for the human services delivery system, they are able to share with providers, government, and the community at large information regarding the needs in the community that are not met. Needs are broken down by financial or basic (e.g., food, shelter, mental health, etc.). Ms. L'Herrou also mentioned the many benefits of 2-1-1, e.g. being available to everybody 24/7; assistance during national disasters and emergencies; and support for the 911 system.

a. Curfew Letter: Assistant Chief Clint Shannon of the Palm Beach Gardens Police Department

Assistant Chief Clint Shannon reminded the committee of a sample curfew letter mentioned by Chief Stephen Stepp at the last LEPC meeting. The curfew letter has been effective in Palm Beach Gardens. He mentioned some of the issues with Regional ID cards including difficulties in issuing them, getting the cards back, and turnover with public work employees. He also suggested discussing this issue with the Treasure Coasts Chiefs Association as many employees live north of Palm Beach County.

## X. Committee/Workgroup Reports

- a. Book and Release Committee: No report was presented.
- b. Recruitment and Retention Committee: No report was presented.
- c. Sexual Assault Response Team: Chief Jenkins announced that they are still looking for 5-6 subcommittee members countywide with sexual assault experience in their past work history. There is a regional SART meeting on September 18<sup>th</sup>, 8:30-4:30 at the PBSO training facility, 4215 Cherry Road, West Palm Beach.
- d. Court Systems Task Force: No report was presented.
- e. Sex Offender Population: No report was presented.

## XI. Liaison Updates

a. Data Sharing: Chief Kitzerow recognized retired Broward Sheriff Al Lamberti, Law Enforcement Coordinator of ROCIC (Regional Organized Crime Information Center) who provided information about ROCIC services that are available for free to members. ROCIC is one of the 6 RISS (Regional Information Sharing Systems) in the country that is federally funded by the

Bureau of Justice Assistance (BJA). Mr. Lamberti asked any agency interested in becoming a member to contact him.

Chief Kitzerow provided a LEX status update on departments that are just coming online: Lantana 100% complete; Palm Beach 98%; North Palm Beach about 40%; and Riviera Beach 20%. He also thanked Denise Vidal Bennette, Clemente Ortiz, Ted Gonzales, and Penny Anderson for their hard work.

- b. Child Abuse Protocol: No report was presented.
- c. Criminal Justice Commission: No report was presented.
- d. Criminal Justice Institute: Director Schroeder reported that they have graduation tonight for Corrections Academy 154 (part-time), leaving them with two full-time academies still in session. On Monday, they started Class 175 (with 35 recruits). On Tuesday night they start Class 176 (part-time academy, with around 30 recruits). The next Regional XII Training Commission meeting will be held before the September LEPC meeting. In February, the Criminal Justice Standards and Training Commission meeting is tentatively set for Jupiter. And lastly, Director Schroeder announced that they are offering an ATV instructor course, but need a location (beach front, wooded or undeveloped area) for the training. He said he will be reaching out to municipalities that may have access to such areas.
- e. High-Intensity Drug Trafficking Area: Colonel Stormes announced they are having their executive board meeting in September.
- f. High School Criminal Justice Academies: No report presented.
- g. Communications/Interoperability: No report presented.
