 - a. MacArthur Safety and Justice Challenge: The Safety and Justice Challenge is a \$100 million national initiative supported by the John D. and Catherine T. MacArthur Foundation. Ms. Henson advised that Palm Beach County was awarded \$2 million from the Foundation. She provided the five strategies that will be employed in PBC. The Frequent Users System Engagement (FUSE) project was also discussed. FUSE will be implemented to provide housing, intensive case management, and services to individuals. Chief

Mooney commented on the program benefits of addressing frequent flyers in the system. Ms. Henson also provided information about a risk assessment and court reminder system.

SB 249 Overdose and Reporting: Ms. Henson reviewed SB 249 signed by the Governor on June 2, 2017 effective October 1, 2017

Summary Details:

Line 67 – any service that treats an overdose victim "may" report information – not required to

Line 71 – reports to be made to the Florida Department of Health Emergency Medical Service Tracking and Reporting System or other method including the High Intensity Drug Trafficking Overdose program

Line 80 – data from these reports must be made available by DOH to a first responders, law enforcement and others within 120 hours

Line 117 – quarterly reports by DOH to variety of sources include the Florida FUSION Centers

Line 140 – Hospitals with ERs "shall" develop best practice plans to promote prevention of unintentional drug overdoses.'

Law Enforcement Workgroup – Ms. Henson advised that \$20,000 was allocated for DNA testing of firearms.
