I. Welcome and opening comments by Chief Daniel Alexander, Chairman

Chairman Alexander thanked Chief Kummerlen and the West Palm Beach Police Department for hosting today's meeting.

- VI. Chairman's Comments
 - a. Reminded members that the December meeting has been cancelled.

VII. Presentations

a. DNA Direct Changes

Dr. Cecelia Crouse, Crime Laboratory Director, provided a brief history and update on the DNA Direct program. Last year, they spent half a million dollars from the Sheriff's budget, and so they wanted to make sure that they are spending resources efficiently. They looked at all DNA analysis requests for a one-year period between October 1, 2013 and September 30, 2014. Of 844 profiles entered in CODIS, 446 were from property crimes; 239 CODIS hits, 251 of which were related to property crimes (55 violent crimes). The objective of the one-year study was to determine what kinds of profiles are usable and can be entered into the database. During the study period, they collected a total of 2,403 samples. Of the total samples, 1,237 were standard samples from individuals for which they predict getting results; and 1,166 samples were from touch DNA which they were not sure if they would yield results. Based upon analysis, they determined that 73% of the touch DNA samples were ineligible for CODIS. As a result, the following changes will be made effective January 1st.

1) prioritize DNA analysis for samples with biological fluids; 2) touch samples from doors, handles, and objects not left by the suspect will not be accepted by the vendor (this does not mean to stop collecting from these items as future DNA testing may be applicable); and 3) decrease the number of samples from two to one. Dr. Crouse noted that just from these two changes, they will save \$154,000 and \$90,000 respectively, already just a little less than half of the total amount of money they spent last year. However, Dr. Crouse still encouraged the agencies to continue collecting samples because they may have the technology to process it in the future, or they may be related to other crimes.

b. LEX Program

Mr. Ted Gonzales, LEX Countywide Program Director, talked about the continued growth of LEX. He thanked LEX staff, Denise Vidal Bennette, Penny Anderson, Clemente Ortiz, Rick Adams, and Jim Johnston. LEX has been growing with over 200 agencies contributing RMS data, with an increase in distinct user request queries. More law enforcement agencies are using LEX, and they are reaching out to state and federal agencies. There has also been an increase in bulletins posted in LEX. More agencies are contributing RMS data; a few in the planning, implementation or quality assurance phase; and they are continuing to talk to additional agencies for future inclusion. A new version, LEX 3.0, is slated for release the first quarter of 2015. Mr. Gonzalez started a demo but ran into technical difficulties; he will resume the demo at the January meeting.

c. Palm Beach County ISS Network Services

Mr. Mike Butler, Network Services Director of PBC Information Systems Services, gave an overview of resources available to everyone for collaboration purposes. He talked about the Palm Beach County Broadband Coalition, comprised of six member agencies, and its history. The coalition was created in 2006 primarily to provide internet access or connectivity between entities and to leverage technology or common resources for the group and the community. There are currently over 40 public sector partners. Mr. Butler also talked about Florida LambdaRail which is a fiber optic ring that circles the state. They have direct firewall attachment to the network. Mr. Butler briefly discussed their connections to various entities and the internet, enabling a secure connection to LEX. Lastly, he touched briefly on their options for increased capacity, including PBC Fiber Network, ATT Data Circuits, and WiMax.

Chief Yannuzzi asked if they lease fiber from AT&T. Mr. Butler said no, they lease transport services from AT&T. He also inquired if they are connected to the FDOT fiber. Mr. Butler advised that they aren't due to a procedural issue. At present, there is a rule that limits use of FDOT fiber for traffic purposes only. Chairman Alexander asked if FDOT is the ultimate authority when it comes to access. Mr. Butler said yes, and Florida Highway Administration defers to FDOT. This issue is already on PBC ISS's legislative agenda, and they are currently working with FDOT, along with other counties (Martin, Saint Lucie, and Broward).

Chief Kitzerow nominated Director Blouin for Chairman, following longstanding tradition of outgoing President of the Palm Beach County Chiefs of Police Association elected as LEPC Chair; and Chief Brian Smith as Vice-Chairman; the vote was unanimous. Chairman Alexander congratulated Director Blouin and Chief Smith.

He thanked West Palm Beach Police Department for allowing them to provide the demonstration.
