The purpose was to bring attention to challenges, opportunities, and solutions regarding juvenile reentry in our County. Highlighted during this discussion was the need to develop consistency throughout the reentry process for juveniles. A report recommending solutions to effective juvenile reentry will be provided to the CJC at a later date.

The Council of State Governments Justice Center provides technical assistance for our 2013 2nd Chance Act Grant for juveniles.
