Follow up discussion on staff's recommendation to merge the SJC Core Team with the Corrections Taskforce/PSCC with an effective transition date for the purpose of eliminating duplication and build sustainability. Both committee's roles are similar and designed to address improvements in jails/corrections. *Example: a recent request was made to the Corrections Taskforce by a representative of PB Bail Bonds Association to recommend the revocation of the Chief Judge's Modification of Administrative Order (AO) number 12.510 Subsection VII, which as are result of COVID-19, reduced bonds for certain 3<sup>rd</sup> degree felonies from \$3,000.00 to \$1,000.00. This issue, which falls within the scope of both committees, could have a major impact on the outcomes of the SJC project.*
