NOW, THEREFORE, in consideration of one dollar (\$1.00), the County not immediately enforcing its rights or the rights of any others now existing, or which may in the future exist, and other good and valuable consideration, the receipt of which is hereby acknowledged, the owner hereby agrees with Palm Beach County to remove at no expense to Palm Beach County, or the beneficiaries or holders of the easement, the structure from the easement within fifteen (15) days of written notice addressed to him or his successors in interest at the property,

notifying him that said structure is or will impede the use of the easement. It is agreed by the owner that the structure shall be as depicted (including location) on the Construction Exhibit, attached hereto, and made a part hereof, and that no other structure shall be placed in said easement. For and in consideration of an additional one dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, owner hereby agrees to indemnify, defend, and save County harmless against and from any and all claims, demands,

this Agreement.

In the event that the owner fails to remove any structure located in the easement within the fifteen (15) days set forth herein, County, or the easement beneficiary, may remove the structure(s) without further notice, and the owner shall be responsible for the County's direct and indirect costs of removal. The County may record, and such costs of removal shall be, a lien against the property.

County, and the easement beneficiaries, shall not be responsible to owner for damage to any structures, the property, or any plants or landscaping in the easement caused through utilization of the easement.

It is agreed by the owner, his heirs, successors, and assigns hereto that this Agreement will be recorded in the Official Records of Palm Beach County, Florida, and that this Agreement shall be a covenant running with the land and be binding upon the owner, his heirs, personal representatives, grantees, assigns and successors in interest of the owners.
