(INDIVIDUAL)

WHEREAS, is/are the fee

WHEREAS, owner desires to erect a, hereinafter

WHEREAS, the owner covenants that he is the fee simple owner of the property and that							
there is/is not at present a mortgage held by; and							
WHEREAS, the structure is erected for the public safety, proper functioning of the home							
special aesthetics, or preservation of natural vegetation.							
NOW, THEREFORE, in consideration of one dollar (\$1.00), the County not immediately							
enforcing its rights or the rights of any others now existing, or which may in the future exist							
and other good and valuable consideration, the receipt of which is hereby acknowledged, the							
owner hereby agrees with Palm Beach County to remove at no expense to Palm Beach County							
or the beneficiaries or holders of the easement, the structure from the easement within fifteen							
(15) days of written notice addressed to him or his successors in interest at the property,							
(address)							
notifying him that said structure is or will impede the use of the easement. It is agreed by the							
owner that the structure shall be as depicted (including location) on the Construction Exhibit							
attached hereto, and made a part hereof, and that no other structure shall be placed in said							

easement. For and in consideration of an additional one dollar (\$1.00) and other good and

valuable consideration, the receipt of which is hereby acknowledged, owner hereby agrees to								
indemnify, defend, and save County harmless against any and all claims, demands, actions,								
suits, proceedings, judgments, liabilities, losses and damage to property, (including wrongful								
death and impairment of any property interest), or for any other matter or thing arising out of								
or in any manner connected with this Agreement, the placement of the								
within the easement, or any								
act or omission of Owner, its agents, employees, contractors, licensees and invites. The								
foregoing indemnification shall specifically include indemnification against any negligence								
on the part of the County in allowing theto be								
placed in the location and the manner permitted pursuant to this Agreement.								
In the event that the owner fails to remove any structure located in the easement within								
the fifteen (15) days set forth herein, County, or the easement beneficiary, may remove the								
structure(s) without further notice, and the owner shall be responsible for the County's direct								
and indirect costs of removal. The County may record, and such costs of removal shall be, a								
lien against the property.								
County, and the easement beneficiaries, shall not be responsible to owner for damage to								
any structures, the property, or any plants or landscaping in the easement caused through								
utilization of the easement.								
It is agreed by the owner, his heirs, successors, and assigns hereto that this Agreement								
will be recorded in the Official Records of Palm Beach County, Florida, and that this								
Agreement shall be a covenant running with the land and be binding upon the owner, his heirs,								
personal representatives, grantees, assigns and successors in interest of the owners.
