3. It is agreed by Owner that this Agreement shall be recorded in the public records of Palm Beach County, Florida.

- 4. This declaration shall run with the land and shall be binding on the heirs, personal representatives, grantees, successors and assigns of Owner.

In further consideration of one dollar (\$1.00), together with the acceptance of this permit and the mutual considerations hereinabove stated, Owner agrees to indemnify, defend and save County harmless against any and all claims, demands, actions, suits, proceedings, judgments, liabilities and losses, of whatever nature, including reasonable attorney's fees, arising out of or from the issuance of this permit to Owner.
