

This Amendment No. 4 (AMENDMENT) to the Pathway & Minor Construction Continuing Services Contract (R2023-0255), dated March 14, 2023 (CONTRACT), is made and entered into on January 14, 2025 by and between Palm Beach County, a political subdivision of the State of Florida, by and through its Board of County Commissioners (COUNTY) and Wynn & Sons Environmental Construction Company, LLC (CONTRACTOR) whose Federal ID is 65-0301746 (individually Party and collectively Parties).

WITNESSETH

WHEREAS, the COUNTY and CONTRACTOR entered into the CONTRACT on March 14, 2023 (R2023-0255), as amended on December 19, 2023 (R2023-1839), May 7, 2024 (R2024-0428) and June 11, 2024 (R2024-0674); and

WHEREAS, Section 1 of the Special Provisions of the CONTRACT allows increasing the Contract amount upon mutual written agreement through a Board approved CONTRACT amendment; and

WHEREAS, Amendment No. 1 to the CONTRACT (R2023-1839), dated December 19, 2023, modified the pay items; and

WHEREAS, Amendment No. 2 to the CONTRACT (R2024-0428), dated May 7, 2024, extended the expiration date of the CONTRACT and recognized the CONTRACTOR's name change; and

WHEREAS, Amendment No. 3 to the CONTRACT (R2024-0674), dated June 11, 2024, amended the CONTRACT to add Technical Special Provisions; and

WHEREAS, by this AMENDMENT, the CONTRACTOR and the COUNTY mutually agree to amend the CONTRACT, as provided herein.

NOW, THEREFORE, in consideration of the mutual covenants, promises, and agreements herein contained, the Parties agree as follows:

- 1. The above recitations are true and correct and incorporated herein.
- 2. The Contract amount is hereby amended to increase the amount by \$8,000,000 from \$26,200,000 to \$34,200,000.
- 3. The CONTRACT is hereby amended to add the Nongovernmental Entity Human Trafficking Affidavit (Exhibit A) to the CONTRACT.
- 4. It is the intent of the Parties hereto that this AMENDMENT shall not become binding until the date executed by the COUNTY.
- 5. Except as hereby amended, changed or modified, all other provisions of the CONTRACT, as amended, shall remain in full force and effect.

IN WITNESS WHEREOF, the Board of County Commissioners of Palm Beach County, Florida has made and executed this AMENDMENT to the CONTRACT, as amended, on behalf of the COUNTY, and CONTRACTOR, has hereunto set its hand the day and year above written.
