

**REQUEST FOR PROPOSAL FOR  
TO LEASE COUNTY 570.77 +/- ACRES  
OF AGRICULTURAL RESERVE LAND FOR COMMERCIAL FARMING**

Public notice is hereby given that Palm Beach County is soliciting proposals from qualified parties to lease approximately 570.77+/- acres of Agricultural Reserve land in unincorporated Palm Beach County (PCN [00-42-43-27-05-065-0010](#) and [00-41-46-13-00-000-1030](#)). The parcels are located west of US Highway 441 (State Road 7), north of Atlantic Boulevard and south of Boynton Beach Boulevard. Access to the Property is limited. The parcel is zoned AGR – Agricultural Reserve (Public Ownership District) by Palm Beach County.

The purpose of the lease is to allow for commercial farming of nursery plants or row crops to continue the agricultural use of properties located in the Agricultural Reserve. The awarded respondent will be accepting these properties “AS-IS” and will be responsible to obtain and maintain all necessary permits, including, those associated with farming.
