AMENDMENT #1 - RESPONSE TO ARTIST'S QUESTIONS

- Q1: Are fused glass panels and glass mosaic pieces applied to the wall an acceptable material for this project?
- A1: Proposed art materials, design and installation methods shall adhere to specifications in the Call to Artist's section A. Project Summary and B. Art Design Goals.
- **Q2:** If selected as a Shortlist Artist, I presume the \$1,000 honorarium is for the artist to make one (1) concept art design proposal for just one (1) of the walls.
- **A2:** Per the Call to Artists, section C. Areas for Art Integration, three (3) of the four (4) buildings are designated for art integration. Concept art proposals must address the three (3) designated buildings.
- Q3: Will your committee be choosing one specific wall that all finalists will design an artwork for, or will it be up to the artist to choose for which space to make a finalist proposal?
- **A3:** See answer A2.
- **Q4:** We noticed that the artist fee is capped at 10% of the budget. I presume the artist fee is separate from fabrication fees, even if the artist is a part of the fabrication team that makes the final artworks. Is this correct?
- **A4:** Correct. The artist fee is separate from all other budget line items including fabrication.
- **Q5:** Do you accept Augmented Reality installations installed with sculptures? Do you accept digital wall art?
- **A5:** See answer A1.
- **Q6:** I am an international artist exhibited at Sothby's New York and Saatchi Gallery London; currently reside in Toronto. Please kindly clarify artist's eligibility.
- A6: See section D. Artist Eligibility in the Call to Artists. If you're wondering if applicants need to be residents of the U.S.A. the answer is no. Also per Section G. in the Call to Artists, prior to the Pre-Proposal conference call, Shortlist Artists will also receive a Business Information Form which must be completed and submitted to the Palm Beach County Art in Public Places along with proof that the Artist's business entity is registered to do business in the State of Florida as either a Florida or a Foreign Corporation, or proof that the registration application has been submitted and is pending review.
- **Q7:** Do you have preferred material choices for the wall art?
- A7: See answer A1.
- Q8: Are the following permitted? Printed Adhesive Vinyl, Washable Vinyl wallpaper (applied with wallpaper adhesive), Painted Murals (preferred paint?), Mosaic, Shallow relief (how deep?), Wall Sculpture (how deep and how high?), Suspended Sculpture (any particular weight and size guidelines at this point?)
- **A8:** See answer A1.
- **Q9:** I wasn't able to determine whether or not traditional murals are welcome for this proposal. Is painting directly on surfaces an option or are you interested more in vinyl etc?
- **A9:** See answer A1.
