Meeting Minutes

I. Welcome and Introductions: Houston Tate, Director OCR, called the meeting to order at 6:04 p.m. and introduced all the elected officials in attendance.

II. Opening Remarks: Mayor Melissa McKinlay, Palm Beach County Board of County Commissioners.

Mayor McKinlay congratulated Deputy Chief Michael Gauger on receiving an award from the Royal Palm Beach Rotary Club. Also congratulated Vice Mayor of Royal Palm Beach, Richard Valuntas for his great work with the Attorney General's Office.

Mayor McKinlay reported that there was a community meeting at Palm Beach State College in Belle Glade on 2/20/18. Since 2015, 215 million dollars has been invested in over 1000 projects in the Glades mainly on infrastructure projects. There is also a desperate need for workforce housing in the Glades area.

The Palm Beach Housing Authority has decided not to move forward with the Grand Lakes project, which would have had 384 apartment units. In addition, Winn-Dixie will be filing for bankruptcy and closing 200 stores. The location in Belle Glade may be among the 200. Mayor McKinlay has been lobbying with Winn-Dixie to keep this location open.

The opioid crisis within Palm Beach County is a major focus as well as other manufactured drugs. In the state of Florida, there has been an increase in overdoses due to these drugs. In the near future The Health Care District will be voting on opening an addiction receiving facility in Palm Beach County. This facility will a place where any one that needs help with drug addiction can receive it.

Mayor McKinlay along with Representative Joseph Abruzzo are trying to secure more funding from the Florida legislature for Palm Beach County over and above what the state already gives the county as well as being in the process to secure the 786 million dollars needed to repair the Herbert Hoover Dyke.

Mayor McKinlay reported that on the November ballot there will be an item to increase homestead exemption another \$25,000. This will be a benefit for many property owners but if this item is passed, there will be a budget shortfall for Palm Beach County.

Mayor McKinlay stated that what the CCRT does is absolutely phenomenal. Mayor McKinlay had to cut her presentation short to attend a meeting hosted by West Palm Beach Commissioner Shannon Materio along with Dr. Mary Stratos, principal of Forest Hill High School at Conniston Middle School on Talking with Students in response to the school shooting at Marjory Stoneman Douglas High School in Parkland, Fl.

III. Community Conversation: Neighborhood Safety - Chief Deputy Michael Gauger, Palm Beach County Sheriff's Office (PBSO).

Chief Deputy Gauger's community conversation focused on Neighborhood Safety. The focus was on Public Safety, Community Safety and Interaction with Police.

The public safety focus was:

- How do we empower our communities
- How can we make our neighborhoods safer

The community safety focus was:

- Community Pride
- Challenges in communities such as gun violence, gangs, drugs, truancy, lack of community communication, lack of trust in law enforcement and felony records.

Interaction with Police focused on:

- Communities involvement with Police Athletic League (PAL)
- Recreational opportunities. i.e. Parks

V. OCR Updates:

Michael Sklar, PBC Housing and Economic Sustainability (HES)

• Haverhill Road Resurfacing Project (Cannongate-Southwoods, Dillman Heights, Forest Homes, Sleepy Hollow, and Wallis Street West) - Milling and resurfacing roadway from Summit Boulevard to Belvedere Road. CDBG funds allocated - \$568,009.

<u>Project Update:</u> The project is under the management of County Engineering. Contract was awarded in December 2017 and work is currently in progress. Construction is scheduled to be completed by August 1, 2018.
