Recognizing the unmet need for access to health care among many Palm Beach County residents, the Board of Directors decided to expand services and launch Foundcare, Inc. as a community health center. Since then, the organization has remained committed to fulfilling unmet health care and social service needs, and has grown to seven sites throughout Palm Beach

County.

Foundcare's mission is to provide comprehensive quality healthcare and social services for all individuals and families so that they have the opportunity to thrive and reach their full health potential while providing a vast variety of services in English, Spanish, French, and Creole to make our services inclusive for everyone.
