II. Department Updates

Michael Owens, Palm Beach County School Representative, reported the following:

• Regarding the FAU Clinic near Westgate Elementary where traffic issues have been an on-going problem and discussed in previous CCRT meetings. The access for the clinic is on Osceola but that access has been closed, so the clinic has been using the school's property for access, which is illegal. The School District is currently meeting with attorneys to draft an "Access Agreement".

Sgt Hightower, Palm Beach Sheriff's Office, reported the following:

 PBSO is gearing up for the Holiday Season with its annual Shop with a Cop Initiative, which will be on November 9, 2014 at 9a.m. and helping to feed families in need for Thanksgiving.

III. Special Presentation- Wendy Friswell, Executive Director, Spirit of Giving Network, Inc.

• The Spirit of Giving Network, Inc. unites more than 60 of Southern Palm Beach County's greatest non-profit organizations to share resources and knowledge with the purpose of building strong vibrant communities. By working together with citizens, businesses and community partners they create alliances and programs that promote lasting change including: Community Volunteer Training, Screening and Placement, Annual Back to School Bash, Annual Holiday Gift Drive, Community Involvement Marketing Campaign, Community Non-profit Meetings and Community Non-profit Calendar.

Ms. Friswell, expressed the importance of getting residents out of their comfort zone to volunteer and being able as leaders to just listen to the residents, to really determine the needs in the community.

Sgt. Hightower also stated that he would follow-up and provide Mrs. Mathews with all the contacts and information via email.
