V. OLD BUSINESS

Committee Member, Brenda Znachko, noted a revision in the previous construction estimate for the CM for Fire Stations (#49, #24 and Lake Worth West). On February 2, 2022, FDO presented the project to the Committee with a cost estimate of \$34,900,000. The estimate is \$20,700,000.

VI. NEW BUSINESS

Angela Smith gave an update on the Civil Engineering Annual Services on a Consultant Service Authorization Basis contract. The Goal Setting Committee approved an API of 20% SBE min. mandatory with an MBE Evaluation Preference for Professional Services (African American). Twelve firms submitted proposals however; four firms were selected for this contract. One of the selected firms is African American-owned. All of the selected firms have agreed to S/MBE participation ranging from 26% to 66%.
