#### I. Call to Order

Mr. Gray and Ms. Harp acknowledged the online participants.

# II. Adoption of February 19, 2025, Agenda

MOTION to adopt the agenda. Motion by Keith Clinkscale, seconded by Irwin Jacobowitz, and carried 6-0.

# III. Approval of February 5, 2025, Minutes

MOTION to approve the minutes. Motion by Stephanie Sejnoha, seconded by Irwin Jacobowitz, and carried 6-0.

## IV. Review of Projects

1. Project No.: 2025053 Traffic Signal Engineering Professional Continuing Services Contract – ENG \$1,000,000

Ms. Knight provided details about the proposed project and the recommendations.

Ms. Smith stated that OEBO agreed with the recommended API of SBE Mandatory Minimum Subcontracting Goal of 20 percent with an SBE Evaluation Preference for SBE Participation and an M/WBE Subcontracting Goal of 5 percent.

Mr. Jacobowitz inquired about the 5 percent African American goal, and Ms. Smith clarified that the 5 percent was in addition to the required 20 percent.

Ms. Znachko inquired about the number of firms, and Ms. Knight responded, stating that there would be two firms.

MOTION to apply the recommended API of SBE Mandatory Minimum Subcontracting Goal of 20 percent with an SBE Evaluation Preference for SBE Participation and an M/WBE Subcontracting Goal of 5 percent. Motion by Irwin Jacobowitz, seconded by Keith Clinkscale, and carried 7-0.

2. Project No.: 2025051 Structural Engineering Professional Continuing Services Contract – ENG \$2,000,000

Ms. Knight provided details about the proposed project and recommendations.

Ms. Smith stated that OEBO agreed with the recommended API of SBE Mandatory Minimum Subcontracting Goal of 20 percent with 5 percent required to be African American-owned firms, and an SBE Evaluation Preference for SBE Participation.

Ms. Znachko inquired about the number of firms. Ms. Knight responded that there would be four firms for the contract.

Discussion ensued regarding the firms, MBE preference, and alternative recommendations.

Mr. Gray proposed an alternative recommendation of 10 percent minimum African American participation.

Ms. Knight suggested an alternative recommendation of 8 percent minimum African American participation.

Discussion continued.

MOTION to apply the recommended API of SBE Mandatory Minimum Subcontracting Goal of 20 percent of which 8 percent must be African American-owned firms, and an SBE Evaluation Preference for SBE Participation. Motion by Brenda Znachko, seconded by Irwin Jacobowitz, and carried 7-0.

3. Project No.: 2025052 Intersection Improvements Professional Services Contract – ENG \$2,000,000

Ms. Knight provided details about the proposed project and recommendations.

Ms. Znachko inquired about the details of the contract, and Ms. Smith clarified that the details had been corrected through email correspondence.

Ms. Knight stated that two firms would be utilized for the intersection.

Ms. Znachko requested that the number of firms be listed in the details in the future.

MOTION to apply the recommended API of SBE Mandatory Minimum Subcontracting Goal of 20 percent, of which 5 percent would be M/WBE Subcontracting for African American firms, and SBE Evaluation Preference for SBE Participation. Motion by Keith Clinkscale, second by Irwin Jacobowitz, and carried 7-0.

4. Project No.: 2025056 Small Paving and Minor Continuing Services Construction Contract – ENG \$3,000,000

Ms. Knight provided details about the proposed project and recommendations.

Ms. Smith stated that OEBO agreed with the recommended API of SBE Mandatory Minimum Subcontracting Goal of 20 percent of which 2 percent must be MBE African American and/or Hispanic American.

MOTION to apply the recommended API of SBE Subcontracting Mandatory Minimum Subcontracting Goal of 20 percent of which 2 percent must be MBE African American- or Hispanic American-owned firms. Motion by Irwin Jacobowitz, seconded by Mark Broderick, and carried 7-0.

5. Project No.: 2025055 Pathway and Minor Continuing Services Construction Contract – ENG \$35,000,000

Ms. Knight provided details about the proposed project and recommendations.

Ms. Smith stated that OEBO agreed with the recommended API of 15 percent SBE Subcontracting Minimum Mandatory, of which 2 percent would be MBE African American-and/or Hispanic American-owned firms.

MOTION to apply the recommended API of SBE Mandatory Minimum Subcontracting Goal of 15 percent of which 2 percent must be MBE African American- and/or Hispanic American-owned firms. Motion by Mark Broderick, seconded by Stephanie Sejnoha, and carried 7-0.
