South Florida will be host to the Super Bowl on February 2, 2020. In an effort to ensure that adequate "for hire" transportation services exist throughout the Southeast Florida region and to create streamlined permitted process while preserving public safety provisions during special events, the Board of County Commissioners approved an amendment to the Vehicle for Hire Ordinance (VFH) on December 17, 2019.

The ordinance amendment allows for reciprocity within the Southeast Florida area (Miami-Dade, Broward, and Palm Beach Counties) during the special event period, excluding ports, for vehicle for hire companies operating sedans, limousines, vans, and sport utility vehicles and have either a special event decal or valid annual decal with airport privileges issued by one of these counties.

VFH companies desiring to expand their fleet can do so by acquiring a Special Event Decal:

- Application fee: **\$100**
- Application being accepted during: **12/30/19 - 1/31/20**
- Special Event Period: **1/26/20 – 2/9/20** (not valid outside of this range)
- Temporary Special Event Decal requirements and conditions:
 - Temporary Special Event decals will be issued to Palm Beach County VFH companies with a current operating permit who desire to increase their fleet to provide prearranged transportation during the Special Event Period.
- To apply you must submit the following:
 - ✓ Temporary Special Event Permit/Decal Application & Fee
 - ✓ Vehicle Registration or lease/rental agreement
 - ✓ Certificate of Insurance
 - ✓ Certification of Temporary Drivers (see Temporary Driver Certification Form)

- Payment Information
 - Credit Card, Check, Money Order (Cash not Accepted)
 - Checks should be made payable to **Palm Beach County Board of County Commissioners**
 - Fees are non-refundable

NOTE: Palm Beach County taxis with a valid annual decal are able to pick up and drop off from Hard Rock Stadium on the day of the Super Bowl, February 2, 2020. No additional permits are required.
