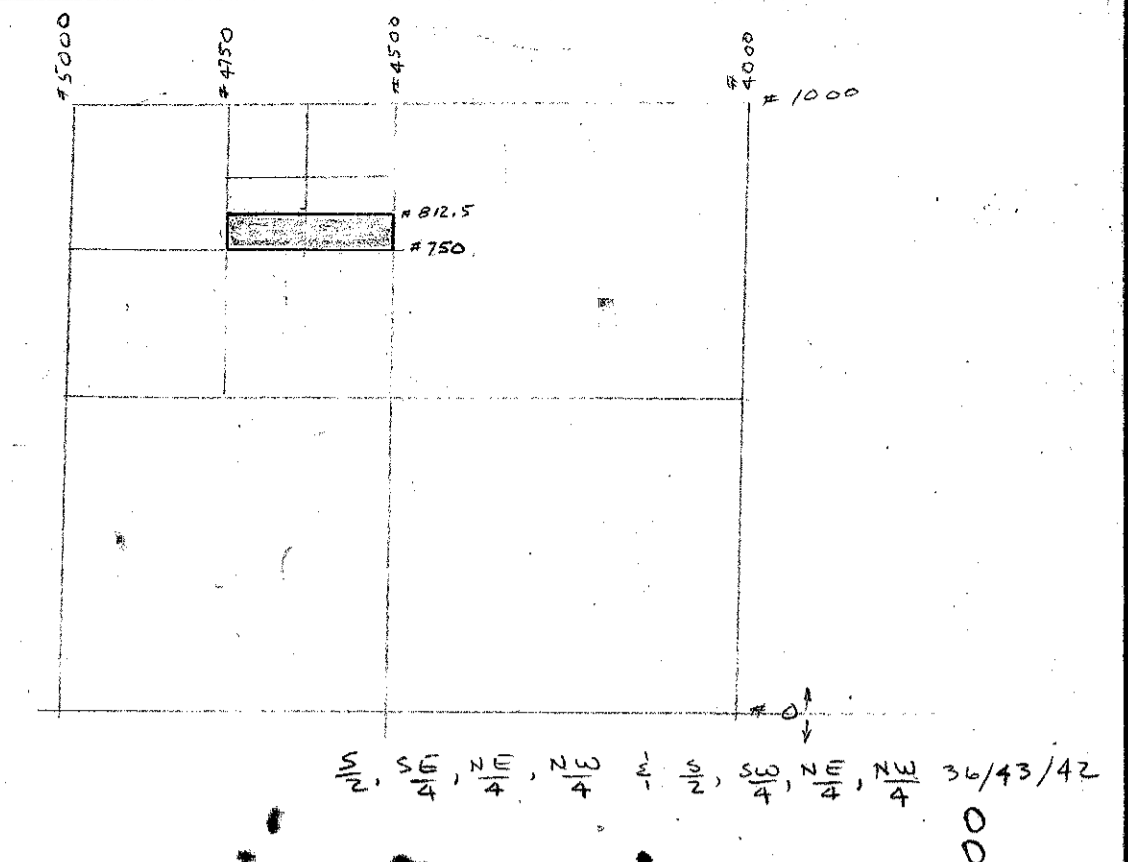

PLAT OF FLEMING PARK

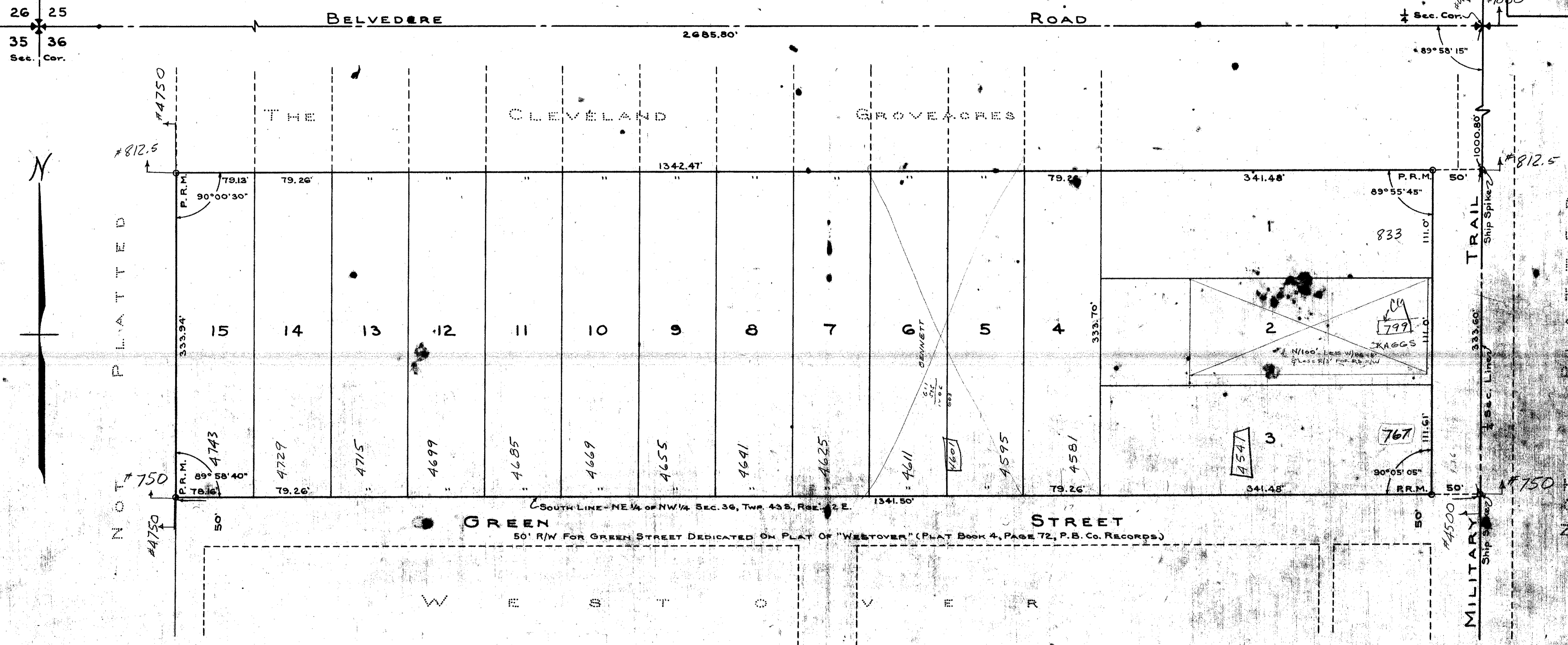
