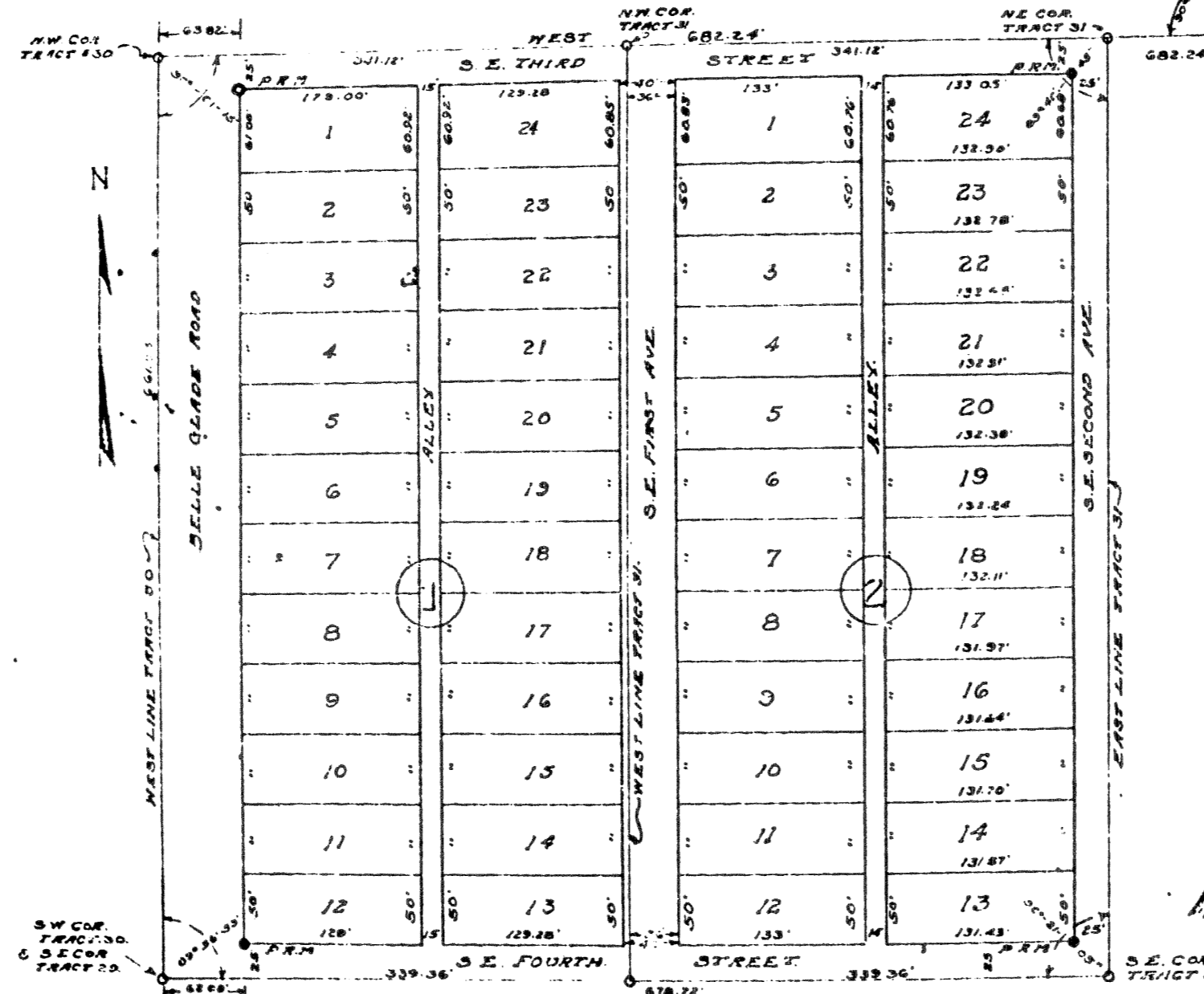


VICTOR L. GEIGER ADDITION
