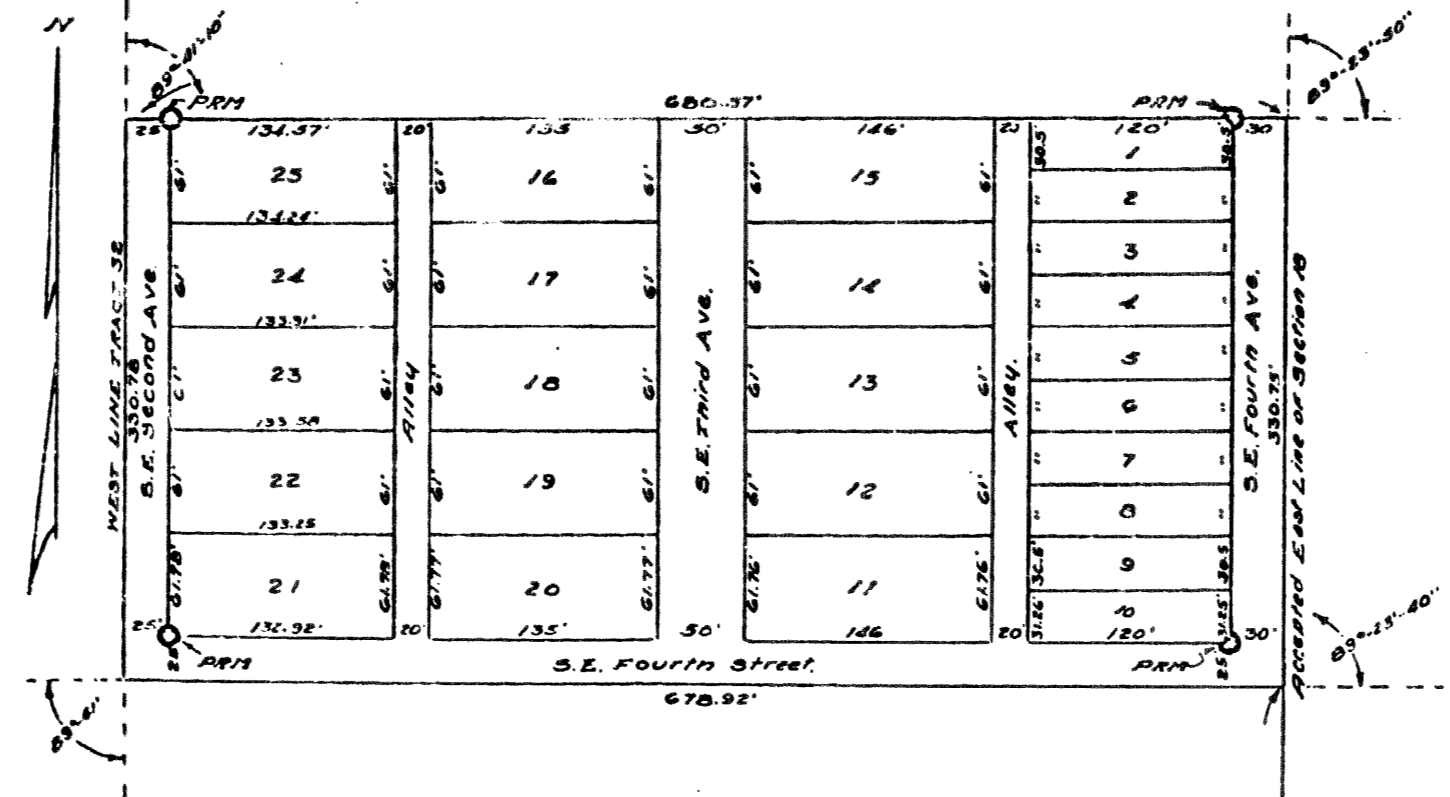


**VICTOR L. GEIGER'S ADDITION

KNOW ALL MEN BY THESE PRESENTS, that VICTOR L. Geiger joined by his wife Virginia Geiger, the owners in fee simple of that tract of land lying and being in Palm Beach County Florida shown on the attached plat as VICTOR L. GEIGER'S ADDITION TO PAHOKEE, BLOCK 3, being more particularly described as follows to wit:

The south half of Tracts 32 and 33 of Ridgeway Beach a subdivision of fractional Section 18 - Township 42 South - Range 37 East, Palm Beach County Florida, according to the plat thereof recorded in Plat Book 7, page 11 of the Palm Beach County Florida Records, have caused the same to be surveyed and divided as shown and do hereby dedicate to the perpetual use of the public the streets, avenues, roads and alleys shown hereon, for use as public highways, reserving however unto themselves, their heirs, assigns, successors or legal representatives, the reversion or reversions thereof, whenever the same shall be abandoned by the public or discontinued by law.
