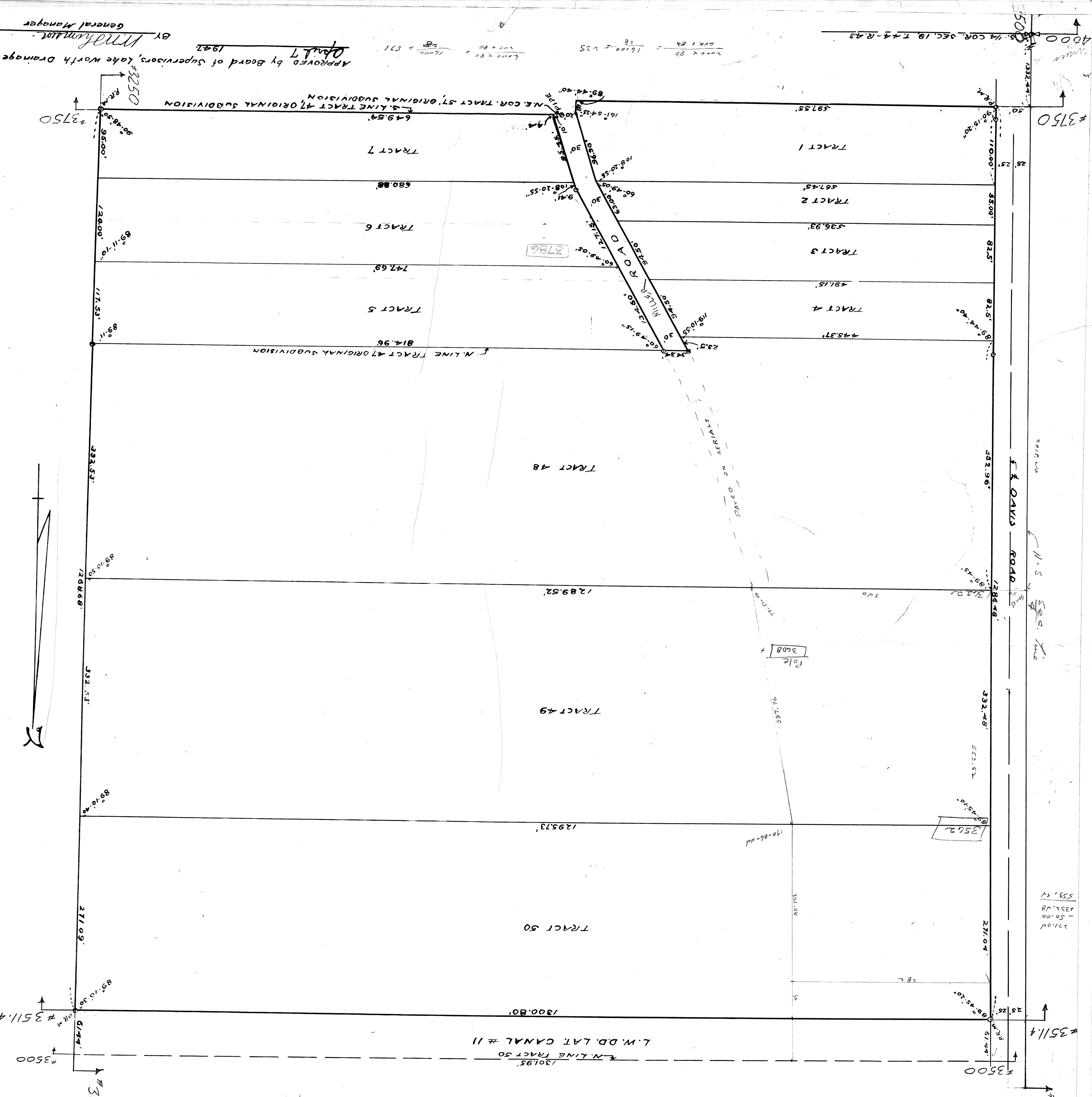


# RESUBDIVISION
