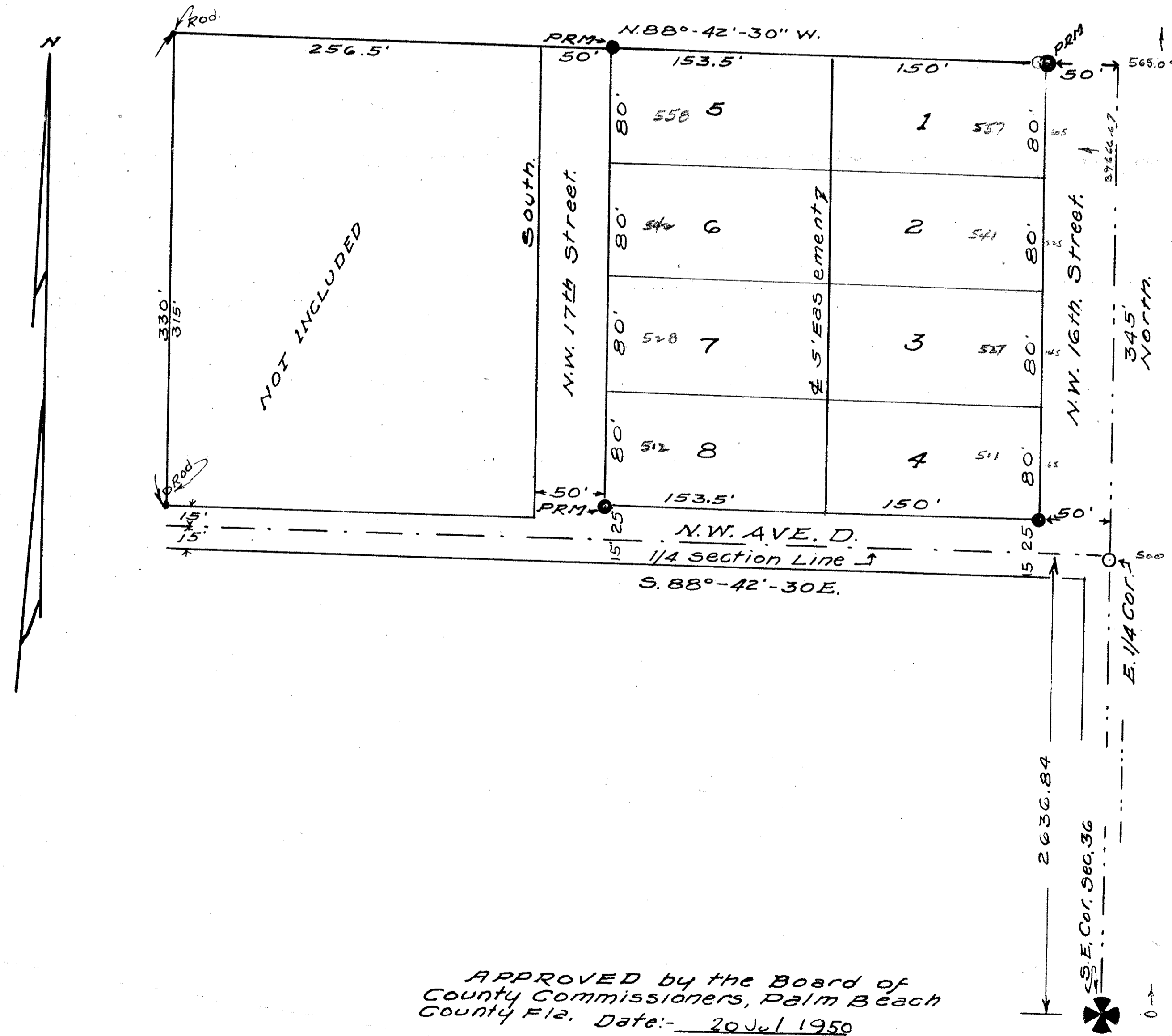

KNOW ALL MEN BY THESE PRESENTS: - that C.B. Rawls joined by his wife, Cleva Rawls, the owners in fee simple of that certain parcel of land lying and being in Palm Beach County Florida, shown on the attached plat as: "INDIANMOUND PARK ANNEX," being more particularly described as the East 388.5 feet of the South 330 feet of State Lot, 1 - Section 36 - Township 43, South - Range 36 East, Palm Beach County Florida, according to a certain plat titled: - "Lands Offered For Sale in the Everglades by the Trustees of the Internal Improvement Fund, Tallahassee, Fla.
