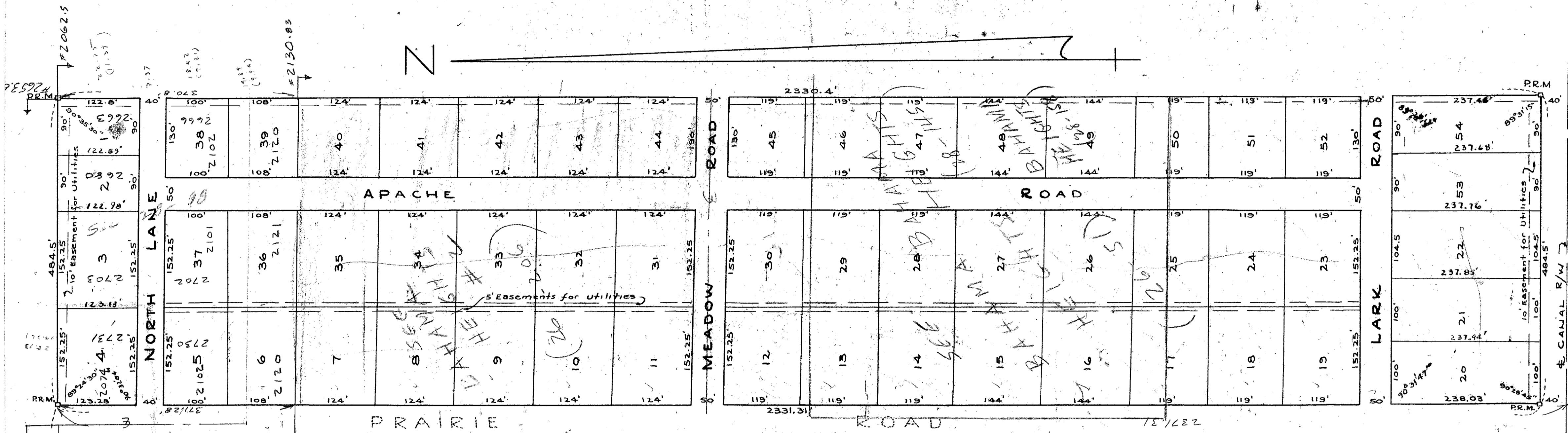
BEING BLOCKS 6, 7 & 8 OF BERMUDA PARK NO. 1,

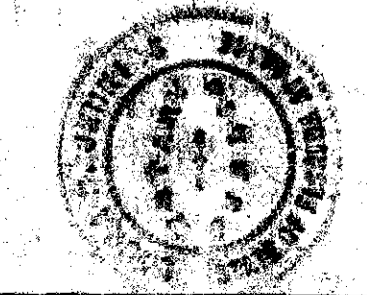
