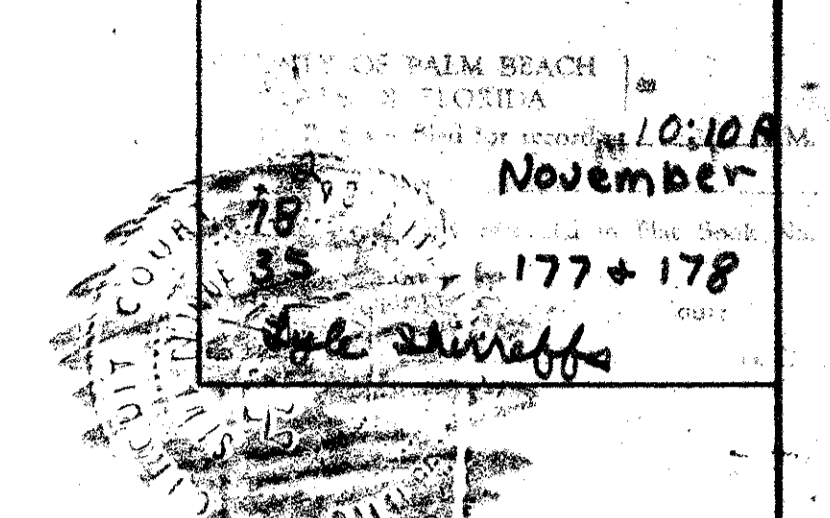

KNOW ALL MEN BY THESE PRESENTS THAT SILVER WOODS LTD, A Florida Limited Partnership, Owner of the  
land shown hereon being in Section 21, Township 47 South, Range 42 East, Palm Beach County, Florida, being a  
portion of Tract 2, BOCA DEL MAR NO. 5 as recorded in Plat Book 30, Pages 127-128 of the Public Records of  
Palm Beach County, Florida, and shown hereon as SILVER WOODS, being more particularly described as follows:

Beginning at the Easternmost corner of the aforementioned Tract 2; thence with a bearing of S. 65° 55' 38" W.,  
along the Southeasterly line of Tract 2, a distance of 443.80 feet to a point; thence with a bearing of S. 86° 28'  
27" W., a distance of 336.91 feet to a point; thence with a bearing of N. 3° 31' 33" W., a distance of 115.00 feet  
to a point; thence with a bearing of S. 86° 28' 27" W., a distance of 5.35 feet to a point of curvature; thence with  
a curve to the right having a radius of 1355.79 feet, an arc length of 30.53 feet to a point; thence with a bearing  
of N. 3° 31' 33" W., a distance of 277.93 feet to a point lying on the South right-of-way line of Del Prado Circle  
North; thence with a bearing of N. 75° 40' 00" E., along said South right-of-way line of Del Prado Circle North,  
a distance of 121.41 feet to a point of curvature; thence with a curve to the right having a radius of 676.20 feet,  
an arc length of 756.83 feet, more or less, to the Point of Beginning.
