

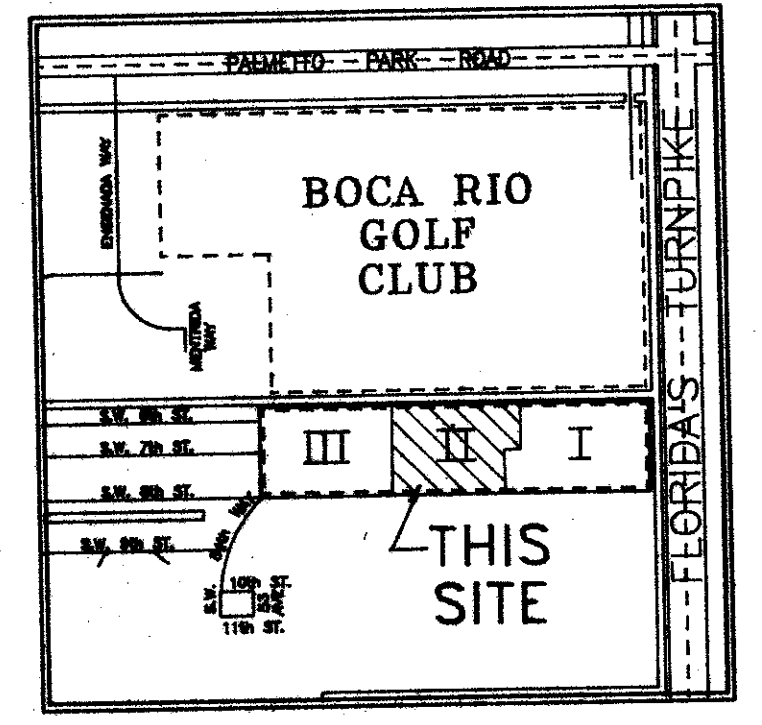

ACCESS, UTILITY, & DRAINAGE EASEMENTS

The Access, Utility and Drainage Easements shown hereon as Boca Rio Drive are hereby dedicated to the Village at Boca Rio Homeowners Association, Inc., and its successors and assigns, licensees, grantees, and/or invites without recourse to Palm Beach County, and is the perpetual maintenance obligation of the Village of Boca Rio Homeowners Association, Inc..

DRAINAGE EASEMENTS

The Drainage Easements as shown hereon are hereby dedicated in perpetuity to the Village at Boca Rio Homeowners Association, Inc., its successors and assigns for the construction, operation, and maintenance of drainage facilities and is the perpetual maintenance obligation of the Village at Boca Rio Homeowners Association, Inc., without recourse to Palm Beach County.

UTILITY EASEMENTS

The Utility Easements shown hereon are hereby dedicated in perpetuity for the construction, operation, and maintenance of utilities.

LIMITED ACCESS EASEMENT

The Limited Access Easement as shown hereon is hereby dedicated to the Board of County Commissioners of Palm Beach County for the control of jurisdiction over access rights.

COMMON AREA

All of the remaining area not contained in the Lots shall be considered common area and is dedicated to the Village at Boca Rio Homeowners Association, Inc., its successors and assigns, and is the perpetual maintenance obligation of said Association without recourse to Palm Beach County.

WATER MANAGEMENT TRACT

The Water Management Tract shown hereon as Lake Tract L-2 is hereby dedicated in perpetuity to the Village at Boca Rio Homeowners Association, Inc., its successors and assigns for lake, water retention purposes, and drainage easement purposes and is the perpetual obligation of the Village at Boca Rio Homeowners Association, Inc., its successors and assigns without recourse to Palm Beach County.

20' LAKE MAINTENANCE EASEMENT

The 20' Lake Maintenance Easement as shown hereon is hereby dedicated to the Village at Boca Rio Homeowners Association, Inc., for the maintenance of Lake Tract L-2, and is the perpetual maintenance obligation of the Village at Boca Rio Homeowners Association, Inc., its successors and assigns without recourse to Palm Beach County.

RIGHT-OF-WAY DEDICATION

The Additional R/W as shown hereon is hereby dedicated to the Board of County Commissioners of Palm Beach County Florida, for the perpetual use of the public for proper purposes.

RECREATIONAL AREA TRACT

Recreational Area Tract is hereby reserved for recreational purposes to the Village at Boca Rio Homeowners Association, Inc. and its successors and assigns, licensees, grantees, and/or invites without recourse to Palm Beach County.

A portion of Tracts 54 through 58, Block 80, PALM BEACH FARMS PLAT NO. 3, a subdivision in Palm Beach County, Florida, according to the Plat thereof, as recorded in the Office of the Clerk of the Circuit Court in and for Palm Beach County, Florida in Plat Book 2, Pages 4 through 54; TOGETHER WITH that certain 30.00 foot platted road right-of-way ing between Tracts 57 and 58, Block 80 of said PALM BEACH FARMS PLAT NO. 3, being more particularly described as follows:

COMMENCING at the intersection of the north line of Tract 51, Block 80 of PALM BEACH FARMS PLAT NO. 3, and a line 1.00 feet West of the West right-of-way line of the Sunshine State Parkway as ascribed in Deed Book 1141, Page 194, of the Public Records of Palm Beach County, Florida; thence North 89° 57'03" West along the North line of said Tract 51 through 54 of said Block 80, a distance of 1357.72 feet to the POINT F BEGINNING of this description; thence continue North 89° 57'03" West along the North line of said Tracts 54 through 58, a distance of 1030.00 feet; thence South 00° 01'02" East along a line 10.00 feet West of and parallel with the East ne of said Tract 58, a distance of 660.00 feet to a point on the South li of said Tract 58; thence South 89° 57'03" East along said South line, a diance of 1122.65 feet; thence North 00° 44'43" West, a distance of 307.56 feet; thence South 89° 57'03" East, a distance of 92.41 feet; thence North 0°44'43" West, a distance of 324.50 feet; thence North 89° 57'03" West, a distare of 177.03 feet; thence North 00° 01'02" West along the East boundary line of sd Tract 55, a distance of 28.00 feet; the last two described courses being fuher described as being on the Southerly and Westerly boundary of that certain parcel of land, as recorded in Deed Book 129, Page 127, of the Palic Records of Palm Beach County, Florida; the last described point being fther described as being the POINT OF BEGINNING. 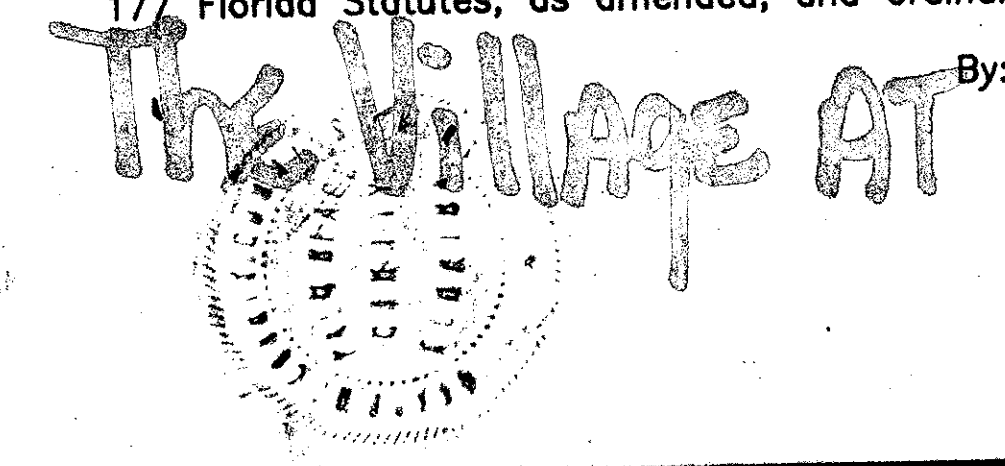
