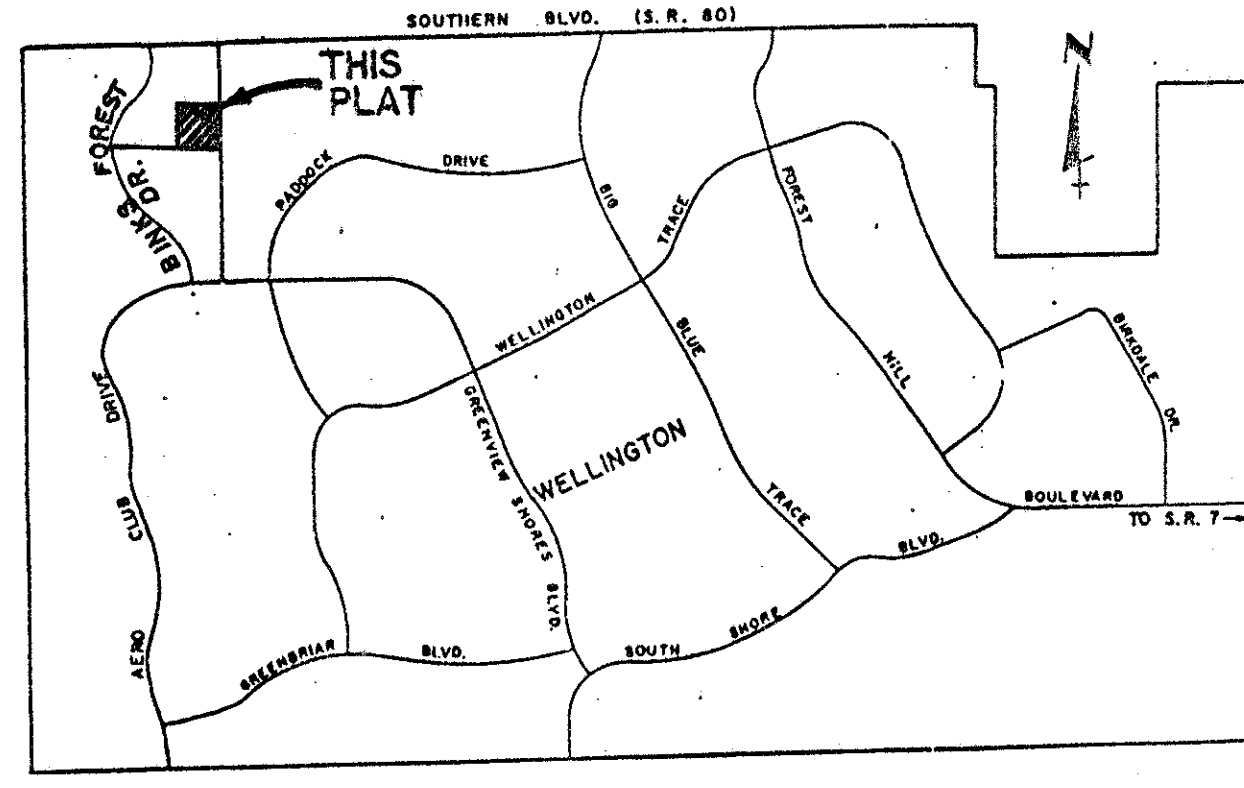


BINK'S FOREST OF THE LANDINGS AT WELLINGTON P. U. D. PLAT 4

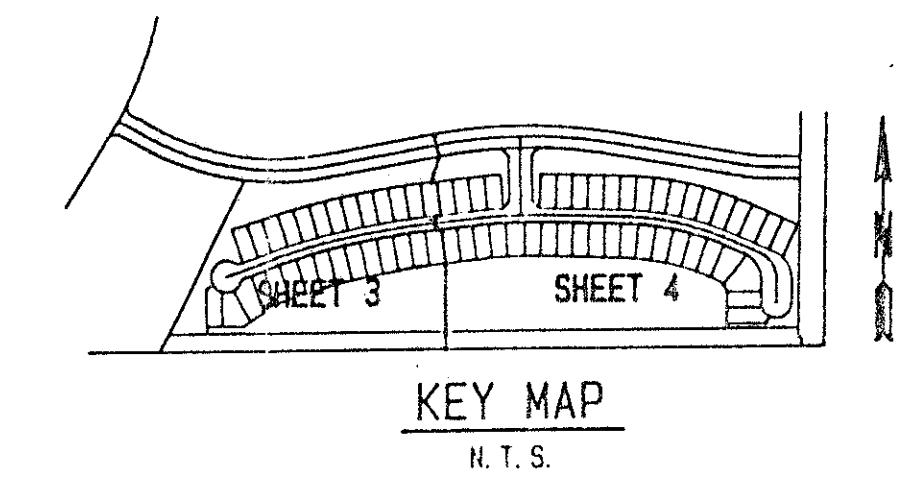

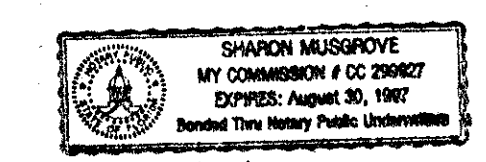

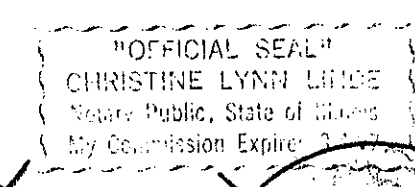
