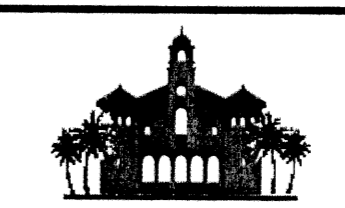


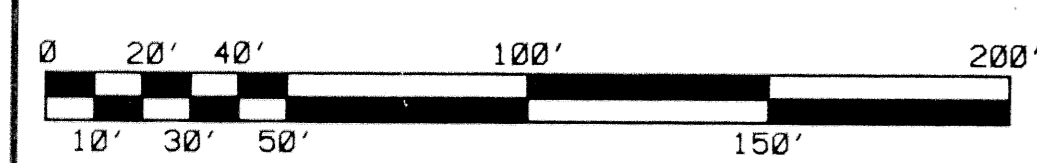

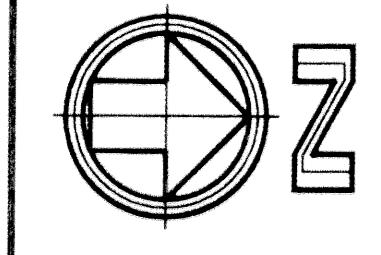
CITY PLACE PLAT No.1

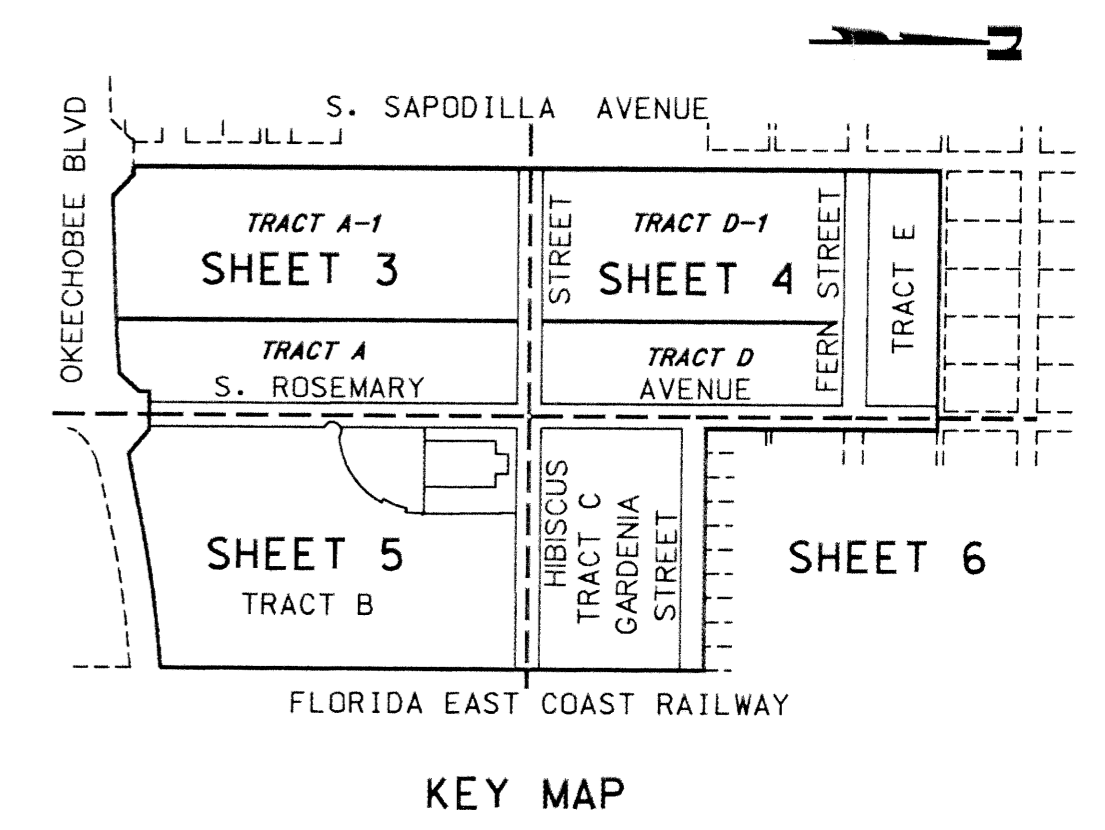
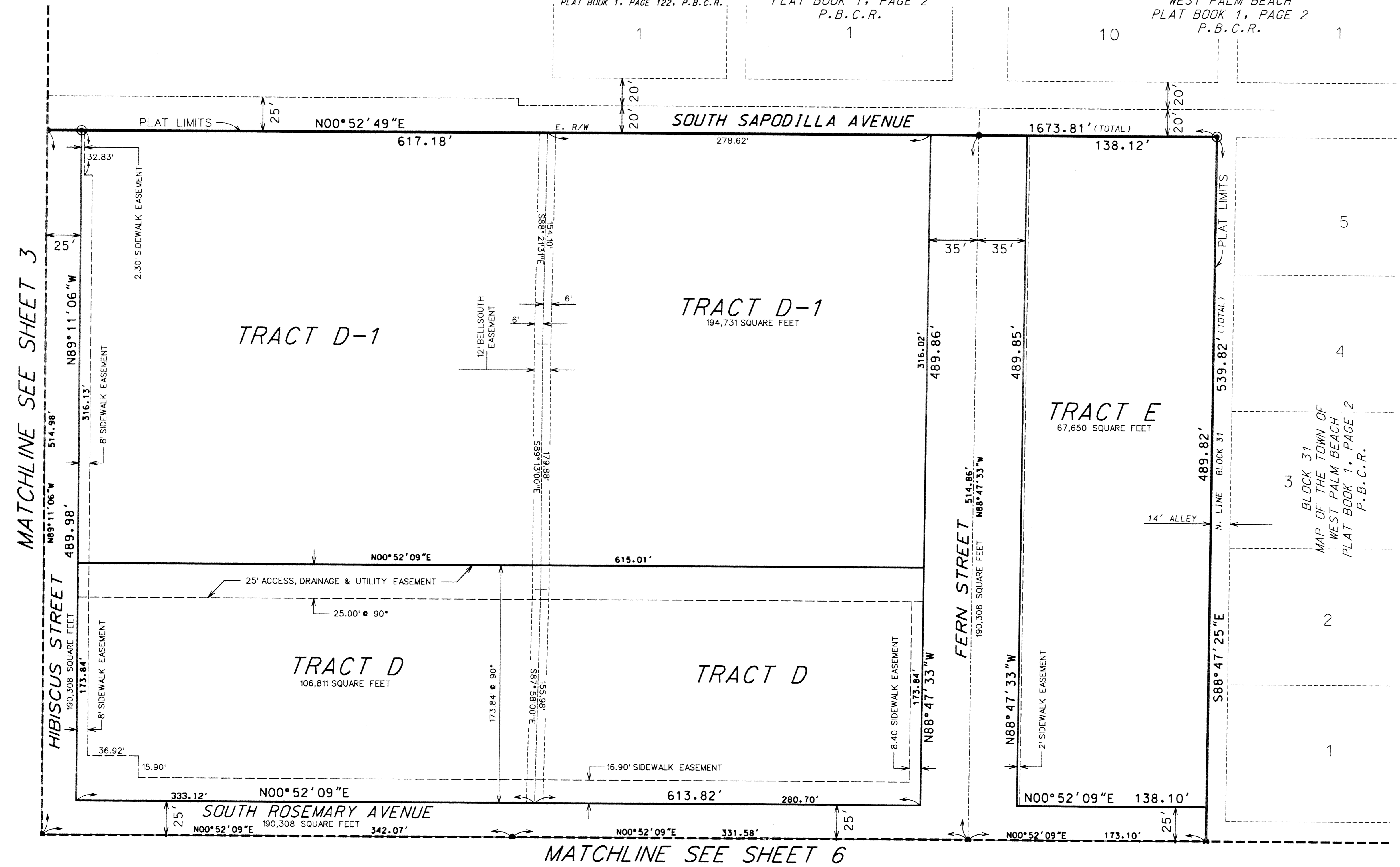
