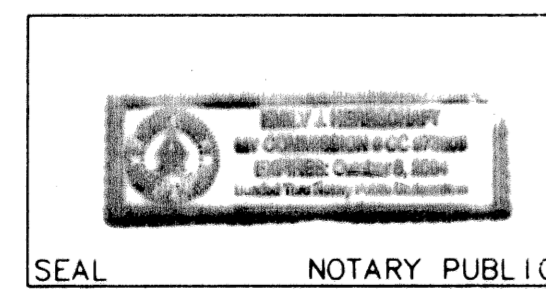

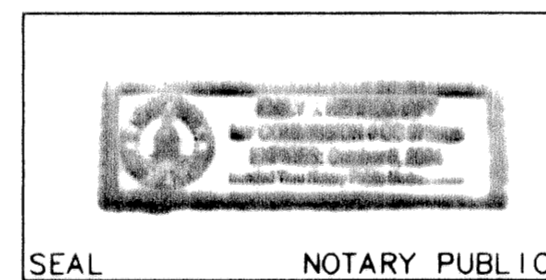

1. ALL BEARINGS SHOWN HEREON ARE BASED ON A BEARING OF SOUTH 45°00'00" EAST ALONG A PORTION OF THE NORTH LINE OF MIRASOL WAY, TRACT A, MIRASOL PLAT FOUR, AS RECORDED IN PLAT BOOK 94, PAGES 149 THROUGH 153, PUBLIC RECORDS OF PALM BEACH COUNTY, FLORIDA.

2. NO BUILDINGS OR ANY KIND OF CONSTRUCTION OR TREES OR SHRUBS SHALL BE PLACED ON ANY EASEMENT WITHOUT PRIOR WRITTEN APPROVAL OF ALL EASEMENT BENEFICIARIES AND ALL APPLICABLE CITY APPROVALS OR PERMITS AS REQUIRED FOR SUCH IMPROVEMENTS.

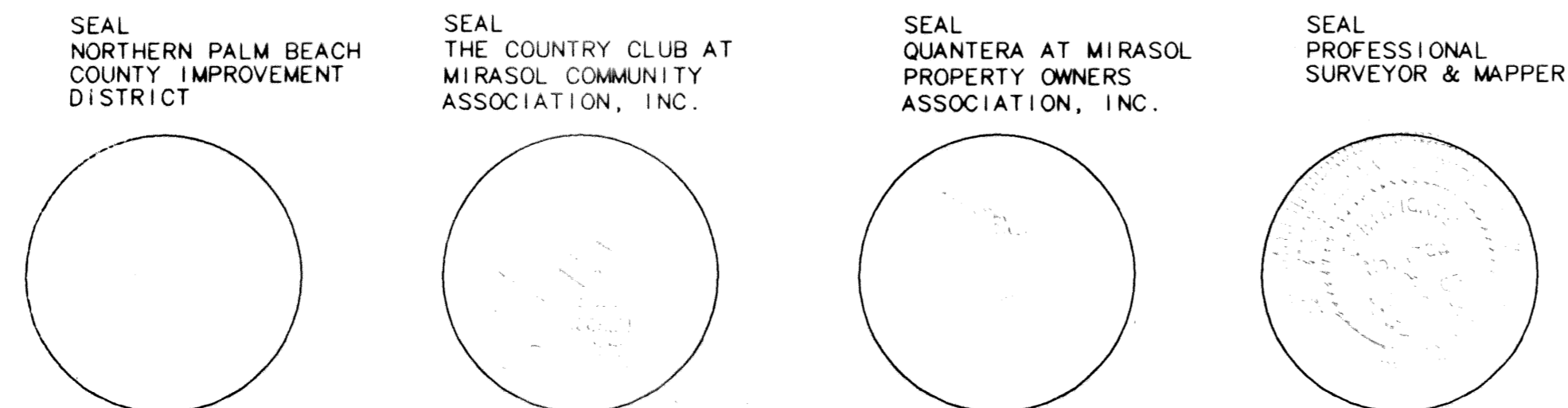
