

## Summary:

The application is for the Learning Center site (FKA Covenant Church). The site was last approved by the Board County Commissioners (BCC) on April 28, 2016, to reconfigure the Site Plan and modify and amend a Condition of Approval (Engineering) for the Place of Worship, Daycare, and Charter School.

The request proposes a Development Order Amendment to delete the Place of Worship and associated conditions of approval. A concurrent Development Review Officer (DRO) application (DRO-2025-00314) proposes to increase square footage, internal to the existing structure (creating a mezzanine), and reallocating the square footage formally for the Place of Worship to the Daycare and Charter School. The number of students/children will remain at 364 for the Charter School and 34 for the Day Care.
